THE INDIAN WAR.

Gen. Bacon Heard From—Large Bodies of Indians From Other Reservations Gathering at the Pillager Camp—Hostilities Will Probably Be Resumed.

MINNEAPOLIS, Minnesota, October 7.—A telegram from Walker says signal fires were seen last night indicating that large bodies of Indians from other reservations had reached the Pillager camp last night. The situation is one of uncertainty today. The tug Flora left at 2 a. m. to bring out Gen. Bacon and his men. Hostilities will probably be resumed tomorrow if the Indians do not surrender.

WALKER, Minnesota, October 7.—General Bacon and his men have arrived. They had no difficulty about landing boats. White flags indicating surrender were seen at several points along the lake. The general says he needs no reinforcements.

GENERAL BACON SAFE.

Has Reported to Army Headquarters at St. Paul.

MINNEAPOLIS, Minnesota, October 7.—General Bacon has at last been heard from. He has telegraphed a list of casualties to army headquarters at St. Paul.

P. E. Triennial Council.

WASHINGTON D. C., October 7.—At the Triennial Episcopal council today the two houses had a joint session to receive a delegation of three from the Canadian branch of the church. Bishop Doan made the speech of welcome.

RAINS VS. RACES.

Hundred Thousand Dollars Tied Up in Pool Box

LEXINGTON, Kentucky, October 7.—Heavy rains postponed the races. They may continue till Monday. A hundred thousand dollars bet on the Transylvania stakes is tied up in the pool box.

BIG STRIKE IN PARIS.

Sixty Thousand Laborers Out—Work on Exhibition Building and Underground Railroad Stopped—Situation Alarming.

PARIS, France, October 7.—The laborers' strike has extended to all the building trades. It is feared it will extend to the railroads. Work on the exhibition buildings and underground railroad has completely ceased. Sixty thousand men are out. The situation is causing consternation. The strikers are increasingly aggressive. Fights between strikers and so-called "blacklegs" are incessant. Troops and police are required to quiet disturbances.

IN CONFLICT.

Kentucky Court of Appeals Declares the Separate Coach Law for Negroes Constitutional—In Conflict With the United States Court.

FRANKFORT, Kentucky, October 7.—The court of appeals today decided the law requiring separate coaches on the state's railroads unconstitutional and that it applied to interstate passengers so long as they were in the state of Kentucky. On this point the decision conflicts with the decision of Judge Barr of the United States court.

Grant's Brigade Coming Home.

PONCE, Puerto Rico, October 7.—Gen. Grant's brigade, the 4th Ohio and 3d Illinois, has been ordered to sail for home about October 18.

Reorganization of Army Corps.

WASHINGTON, D. C., October 7.—A general order was issued yesterday reorganizing the army corps. The third, fifth and sixth corps are discontinued.

The first, second and fourth are reorganized by Major Generals Breckinridge, Graham and Wheeler. The headquarters of the first are to be at Macon; second at Augusta; fourth at Huntsville.

Or, in lieu of that, on the condition that a joint stock company with \$20,000 capital stock be raised (said stock to be paid up stock) he will take \$4,000 of such paid up stock, in lieu of cash, and the balance in cash, if \$15,000 capital stock should be subscribed, he would make it \$20,000 and take \$6,000 in cash.

Mr. Reeves was wishing some such proposition as this, and believing it to be fair he accepted it in person and started out to get up the company. This was but a day or so ago. The first man he talked to on the subject gave him \$2,000 in a subscription. Others have subscribed smaller amounts. Altogether about \$13,000 remains to be raised of the proposed \$20,000 capital stock, and the plan is but in its infancy. Mr. Reeves firmly believes that he will be able to raise the necessary \$20,000 without great difficulty, and would be glad for all who have any interest in the city's welfare and have some money to invest, to come to him or otherwise arrange with him to contribute to this end.

The subscription paper is now to be sent by anyone interested in the plan and wishing to subscribe.

The present situation demands that action be taken promptly, for many reasons. The walls of the present structure on the grounds are sound as a dollar, but cannot long remain so under the rains and winds, but will begin to tremble in the fall. They will be gone over the building and windows put in it before the falling of snow or the beginning of bad weather. Another reason for prompt action is that there is a mortgage on the property, and that mortgage will be foreclosed in time if some action is not taken toward making the property more valuable. It is better to commit the management to a joint stock company and let the world judge that the house can be comfortably and handsomely replaced for the amount designated. The holder of the mortgage is patiently awaiting action and will not foreclose if there is an immediate prospect of the rebuilding of the house. Should the subscriptions be filled before any serious damage has been done to the walls and before repairs are necessary, money could be saved, and there would be a saving for many of means.

The management is to be selected by the stockholders in the company, and Mr. Bradley will have nothing to do with the management, except as his stock permits him to have a voice in the selection of a manager or managers competent to make the most out of the house.

The plan is believed to be a good one, and it should, and it appears will, succeed.
