

IT MAY FREE HIM

Louis Jaquith Is Able to Substantiate Story Told By James Braddie.

SAYS HE DIDN'T SHOOT

Alleged Deathbed Confession of a Man Who Was Involved in Row Corroborated By Convict.

Without Knowledge of the Confession Jaquith Enters Into Substantial Details.

South Bend, Ind., Oct. 19.—Louis Jaquith says he is innocent of the murder of Officer Cooper of South Bend and although he does not directly accuse James Braddie, who last week created a sensation by making an alleged confession in a letter to Governor Durbin to having committed the crime, he does so by implication. He says Braddie was the only man who had a weapon except Cooper. Jaquith was taken from his cell in the state prison on an order from Warden Shideler and brought before the latter. He was not shown Braddie's confession until he had been closely questioned by the warden. With reference to the interview Warden Shideler said: "Jaquith was brought into my office. He was questioned by me before he was made aware of any confession. He admitted that the three—Ragan, Jaquith and Braddie—had broken into the saloon. He said that Ragan picked up a revolver belonging to the saloon keeper, handed it to Braddie, and that when Cooper laid hands on him (Jaquith) the other two interfered. In the fight which followed Jaquith was knocked down with a club in the hands of Officer Cooper. Just at that time a shot was fired, followed by a second shot.

"Before he was shown the confession he said Braddie was in or about Buffalo, from which place the confession had been mailed to Governor Durbin. Jaquith persists in his innocence and says he is in prison because of his previous bad character. He claims that the finding of Braddie will relieve him of his life sentence, although he admits that he should have been sentenced for burglary. Jaquith is a model prisoner, and seems to be putting forth an effort to make the best of a bad situation."

AN ACTIVE PRIEST

Father Dhe Has Engaged In Further Manufacturing Enterprises. Indianapolis, Oct. 19.—The name of Father Charles Dhe of Hartford City appeared as one of the directors of the Mississinewa Window Glass company, capital \$20,000, of Wheeling, which incorporated with the secretary of state yesterday. Father Dhe is the Catholic priest in charge of churches at Hartford City, Dunkirk and Montpelier, who has recently attracted considerable attention as a promoter. He has built factories at Montpelier and Hartford City during the last two years, and it is said that he has other important enterprises that he intends to carry out soon.

From that hour until the present time his whereabouts have been unknown.

New Prison Warden.

Indianapolis, Oct. 19.—The Michigan City prison board of control met in the governor's office yesterday and elected James D. Reid of South Bend warden of the state prison to succeed George A. H. Shideler, who resigned some time ago.

Evansville, Ind., Oct. 19.—Claude Gaultney, five years old, was crushed to death by a rolling log.

Cashier Still Missing.

Boyetown, Pa., Oct. 19.—Nothing has yet been heard respecting the whereabouts of Milton A. Mory, the missing cashier of the National Bank of Boyetown. The committee of bank officials who went to Philadelphia yesterday found that Mory had taken \$105,000 worth of the bank's securities and these securities were found deposited with brokers of that city. What amount Mory had raised on the securities is not announced, but the presumption is that Boyetown bank officials made good the sum secured, as they stated that the securities are again the property of the bank.

Fatal Collision.

St. Louis, Oct. 19.—A rear end collision between a fast mail train and a freight train on the Iron Mountain road, four miles below Desoto, Mo., occurred last night. One man was killed and there were many injured. All the cars were thrown from the track.

A Woman's Suicide.

LaGrange, Ind., Oct. 19.—Mrs. Claude Bryant, a few miles south of this city, committed suicide by taking strychnine. She was aged 23. She had applied for divorce from her husband, owing to domestic disagreements.

Murderers Captured.

Owensboro, Ky., Oct. 19.—John A. Oldham, the racehorse man who was shot in Squire Johnston's court Thursday night died last night at the city hospital. Enoch and James Clary, the murderers, were captured yesterday.

Shot Himself Dead.

Winnipeg, Man., Oct. 19.—Nicholas Flood Daven, a veteran journalist, former member of parliament, and author of several books and plays, shot himself dead yesterday in his room in the Clarendon hotel.

AT THE CAPITAL

Notes and Comment Arranged By Our Indianapolis Correspondent.

Indianapolis, Oct. 19.—Mayor Charles G. Covert of Evansville is here investigating a subject of great interest to southern Indiana. So far the development in the construction of interurban roads has been confined almost exclusively to northern Indiana. Now two companies, composed of reliable gentlemen, have appealed to the Evansville board of works for interurban franchises. They propose, respectively, to construct lines to Booneville and Princeton. Mayor Covert is investigating in a very thorough manner the interurban question and has taken excursions over several roads entering Indianapolis. Yesterday he went to Greenfield over the interurban line. "The companies seeking entrance to our city have, as usual in such cases, submitted propositions that are impossible in almost every detail," he said, "and the board of works will come back with counter propositions. There is a tendency on the part of towns in our part of the state to discourage any enterprise that would take trade from them to Evansville. The merchants of Greenfield tell me, however, that the interurban railway not only does not divert trade to Indianapolis, but increases their own trade and I shall use their argument when I get home." It is expected that the construction of these interurban lines out of Evansville will start an era of interurban development in southern Indiana.

Ex-Representative Leonidas H. Mull of Rush county is at the Grand hotel. He is a brother of ex-Senator Thomas K. Mull, whom the opponents of Congressman Watson have selected as a candidate for the nomination for congress against Watson. Ex-Senator Mull is as strong a Republican as ex-Representative Mull is a Democrat. "My brother will not make the race," said ex-Representative Mull. They are trying to get him to do so, but he will not be a candidate. If he were to enter the race he would defeat Mr. Watson.

Congressman E. D. Crumpacker of Valparaiso, who was here last night, said he is preparing a bill to be introduced in the next congress prohibiting the president from appointing to office the son or son-in-law of any member of congress. He believes that this bill will bring about a salutary reform and that it will not be opposed by President Roosevelt.

Uriah Culbert of Michigan City, the member of the state prison board who is said to be slated for retirement, is at the Denison. "It is probable that I shall be asked to retire," he said, "but I have not received the slightest notice of such intention." Mr. Culbert is interested in a concern that has a prison contract.

State Board of Charities.

South Bend, Ind., Oct. 19.—George A. H. Shideler of Michigan City was elected president of the Indiana conference of charities and Charles H. Grout of Indianapolis secretary, at the session just closed here.

Congressman Robinson Convalescing. Ft. Wayne, Ind., Oct. 19.—It is now believed that Congressman J. M. Robinson has passed the crisis in his acute attack of typhoid fever, and that he will recover.

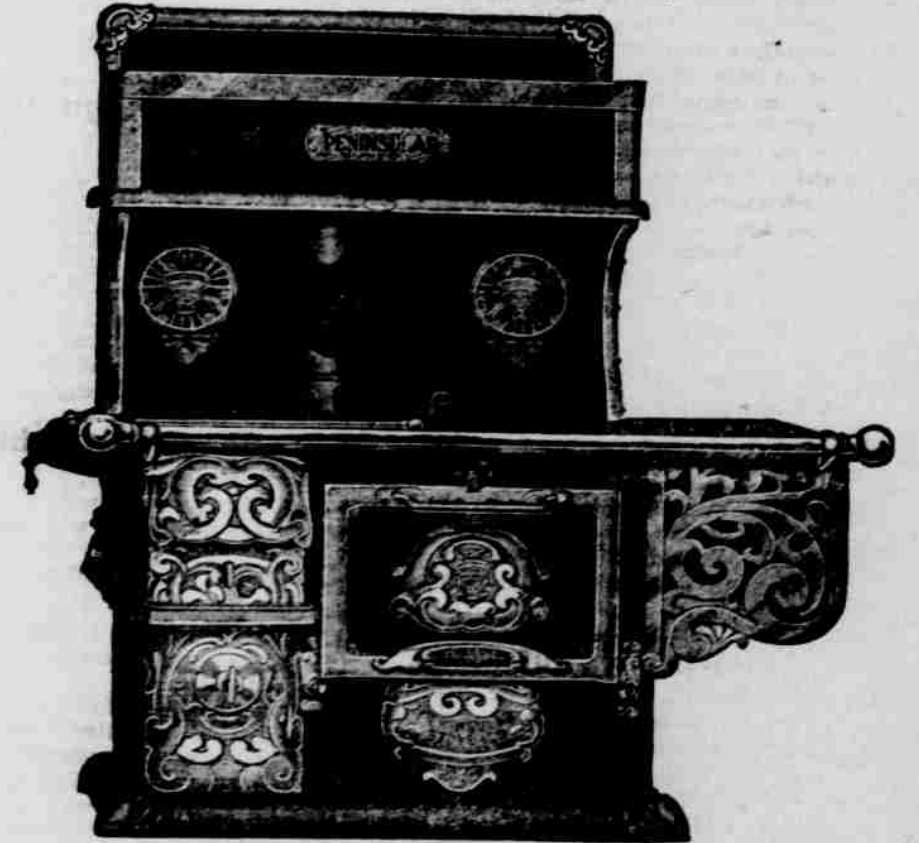
