European Designs Toward United States Four Years Ago Being Revealed.

AUSTRIA DOESN'T CARE

Her Dynastic and Sympathetic Relations With Spain Made Her Course a Natural One.

Germany On the Other Hand Vehemently Denies the Story and Condemns Lord Cranborne.

Vienna, Jan. 22.—Inquiries made at the Austrian-Hungarian foreign office confirm the essential points of the statement made by Lord Cranborne, the British foreign under secretary, in the house of commons Monday. The dynastic relations of Austria with Spain, the queen regent being an arch-duchess of Austria, led Austria before the declaration of war between Spain and the United States, to begin a peace propaganda, which was carried on not only in England but throughout Europe. France was ready to second the efforts of Austria. Germany and Russia maintained a passive attitude. Great Britain was at first disposed to sign the proposed note, but after a confidential report from Washington declined either to sign such a note as the Austrian ambassador proposed, or to take any further steps. Afterward Austria and France made direct representations at Washington, but ceased efforts after the declaration of war. The pope, who was in the approval of all

Indianapolis, Jan. 22.—Harry C. Starr of Richmond, whose dapper as tire has always been a delight to his associates, surprised his friends by appearing among them today looking like a veteran returning from some war. He is but 33 years old now. He also claimed that he is the oldest Elk in point of years of membership in the state. He is a new man in state politics, but his friends think he is running well. Nat U. Hill of Bloomington and T. B. Millikan of Newcas tle, other candidates for treasurer were also here today.

James S. Stutesman of Peru and his friend Henry Marshall of Lafayette were here last night. Both are candidates for the legislature and expect to win out. They will reverse the order of things, however, as to the speaker ship of the house, as Marshall will be the candidate this time instead of Stutesman. Marshall is regarded as anti-Hanly and inasmuch as Hanly has captured the organization in Tippecanoe county, it was thought that Marshall's chances have dimmed, but Marshall said he and Hanly are friends and that he is confident of being nominated.

Mrs. Silas T. Bowen, grandmother of Miss Holman, received a telegram last night confirming the report that the romantic engagement between Miss Holman and Marconi, inventor of the wireless telegraph, has been broken off. No reason was given. Miss Holman is well known in social circles here and the announcement some time ago of her romantic meeting and engagement with the famous inventor was widely written of in all the leading papers. Much surprise is expressed here at its sudden termination.

The annual midwinter meeting of the Republican State Editorial association will begin here tonight with a banquet at the Denison House, at which Governor Durbin, Private Secretary Wilson and Attorney General Taylor will be guests of honor. The regular business session will be held tomorrow afternoon. Nearly all the candidates for state office who were here for the reorganization of the state committee have remained over to meet with the editors.

The Indiana Retail Lumber Dealers association held its annual meeting here today and tonight at 8:30 will leave on their annual Southern excursion, which will include a visit to the Charleston exposition, the eastern coast of Florida, and a week in Cuban ports with Havana as the objective terminal. The trip will last for nearly three weeks. About 100 lumbermen with their wives will take the trip.

A state official who was figuring on the state debt said today that if congress allows Indiana's civil war claim of \$714,000 during the present session that nearly \$1,500,000 of the debt will be wiped out this year and that at the present rate of making payments it will nearly all be squared within the next four years. Then he explained it will be possible to give a low state tax levy.

Arrangements are being made for the annual province convention of the Phi Delta Theta fraternity here the night of the state oratorical contest. It is expected that college men will be here from the entire state. The convention is of much interest to them as the Phi Delta Theta are strong in Indiana, having chapters at nearly every college.

ENGAGEMENT IS OFF

Signor Marconi's fiance Asks And Obtains Her Release. New York, Jan. 22.—Mrs. H. B. Holman of this city has announced that her daughter Josephine had asked Marconi, the developer of wireless telegraphy, to release her from her engagement to marry him, and that Mr. Marconi had complied with her request.

The first announcement of the engagement of Miss Josephine Bower Holman and Mr. Marconi was made in Indianapolis last April, and the prospective marriage was to take place in the autumn. Winter came and the success of Marconi with the wireless telegraph, and the statement was made that on account of the expert merits of the inventor in remote regions it seemed wiser to defer the marriage for a time. No explanation is given regarding the young lady's change of sentiment.

UP AGAINST IT

Democrats Must Abide By the Platform Says Caucus. Washington, Jan. 22.—The committee of 12 appointed by direction of the caucus of house Democrats to consider a number of resolutions outlining the policy to be pursued by the majority during the present congress, have agreed by a vote of 11 to 1 to recommend to the general Democratic caucus which meets on Friday the adoption of a resolution declaring it to be the sense of the Democrats of the house that the caucus is not for the purpose of making platform declarations and has no power to add to or subtract from the national platform already adopted. Mr. Henry of Texas will offer as a substitute a resolution for the reaffirmation of the Kansas City platform.

Congressional

Washington, Jan. 22.—For nearly two hours yesterday the senate has under consideration the Philippine tariff bill. The measure was made the unfinished business and probably will hold that position of preference until it shall have been voted on finally in the absence of other pressing business the house managers are allowing the widest latitude in the debate on the urgent deficiency bill now before the house. The irrigation of arid lands in the West and the advisability of retaining control of the Philippines were the main topics under discussion yesterday.

Proposition receives Favor.

Washington, Jan. 22.—The committee on the election of president and vice president of the house yesterday made a favorable report on the bill for the election of United States senators by direct vote of the people. The report follows literally that of last year and presents the advantages of popular election of senators.

Asks Intervention.

Washington, Jan. 22.—Representative William Alden Smith of Michigan a member of the house committee on foreign affairs, yesterday introduced a resolution directing the state department to request the British government to withhold the sentence of death passed on Commander Schepers, who is about to be shot.
