## ARMY POST SITE

Cash Has Been Paid to Con-  
clude Uncle Sam's In-  
diana Dicker.

## DELAY IN CLOSING DEAL

One Landholder Held Out for an  
Advance on the Original  
Price Asked.

Indianapolis Merchants Fearing Loss  
of the Post Come to the  
Rescue.

Indianapolis, Feb. 2.—Uncle Sam paid out a fortune here today for land to be used for the army post. Capt. Cheatham, his representative, has had \$181,000 here for several days for that purpose and today over twenty-five farmers came in and secured thick rolls of fine, new crisp bank notes. There has been much delay in closing the deal owing to the stubbornness of one of the land owners who evidently regarded Uncle Sam as easy picking and who held out for a much higher price than the land was worth. It was feared that the post might be taken elsewhere, so the Commercial Club and the Merchants' association gave a bond to make good in case the decision should go against the government in condemnation proceedings that will be brought at once to settle the value of the property of the stubborn landowner.

## INTERESTING DECISION

Judge Artman Holds Legislative Ap-  
portionment Act Invalid.

Lebanon, Ind., Feb. 2.—Judge Samuel R. Artman has rendered his decision in the suit recently filed here by the Democrats to test the constitutionality of the last legislative apportionment act. He holds the law unconstitutional on the broad ground of disproportionate apportionment.

The only pleadings submitted by the defendants were in a demurrer which admitted facts mentioned in the complaint to be true, but argued that they did not constitute the cause of action. The demurrer was overruled. The defendants were ruled to answer the complaint, but declined and elected to stand upon the ruling on the demurrer. Judgment was rendered in favor of the plaintiff on the ruling on demurrer. An appeal was taken to the supreme court.

The suit decided by Judge Artman was one of the two suits brought at the instigation of the Democratic state committee. The other suit, which was filed in Dearborn county, is being argued before Judge Downey today. The case was presented to Judge Artman on a demurrer alleging the seven statutory causes of demurrer. By agreement of the attorneys there was no argument, and it was decided that there should be no further pleadings in the lower court, so that no time would be lost in getting the matter before the supreme court. Judge Artman's decision, therefore, goes directly to the constitutionality of the act. His decision that the law is void will bring the same question directly before the supreme court when the appeal is perfected.

No time will be lost in perfecting the appeal to the supreme court. Both parties will join to have an early decision rendered by the court. The party managers are anxious to know under which law the legislative fight must be conducted, and there will be a great deal of delay in making nominations unless the suit is decided within a few weeks.

## Buried Treasure Found.

Logansport, Ind., Feb. 2.—While excavating for the foundation wall of a new barn, Alvin Guthrie uncovered gold pieces aggregating \$980. The land formerly belonged to the late Thomas Guthrie, and the administrator laid claim to the gold. Albert Seybold, present owner of the lot, also claims it, and so does Alvin Guthrie, the latter by right of discovery. Possession will be adjudicated in the courts.

## Democrats Open Headquarters.

Indianapolis, Feb. 2.—The Democratic state committee this week opened temporary headquarters in the Sentinel building. Secretary Kelley will be in charge, but Chairman O'Brien expects to spend much time here. The Democrats are going to organize earlier than ever before. A call has been issued for the election of county committee officers March 1.

## Picked Up a Bargain.

Terre Haute, Ind., Feb. 2.—George Terhosh, proprietor of the Germania saloon, who recently came into possession of a Stradavarius violin, bearing date of 1727, has sold the instrument to a St. Louis musician. He claims to have received \$1,200 for it. He paid \$5 for it three weeks ago.
