### Judge Smith Today.

Philadelphia, Pa., Nov. 22.—When the new cruiser Pennsylvania which made her trial trip over the Cape Ann course yesterday, returns to the League Island yard, she will be presented with a silver service by the people of the state. The service consists of 142 pieces weighing nearly 9000 ounces and covers a table more than fifteen feet long and four feet wide. The total cost is \$25,000. It is the largest and costliest silver service ever presented to any war vessel.
