A NEBRASKIAN FOR CABINET

RUMORED D. E. THOMPSON IS TO SUCCEED MR. HITCHCOCK.

AS SECRETARY OF INTERIOR

Mr. Thompson is Now United States Minister to Brazil.

Washington, D. C., Dec. 6.—There is renewed talk here to the effect that some important changes are being made in the President's Cabinet, among which is the early retirement of Secretary of the Interior Hitchcock. It is not the desire of Mr. Roosevelt that Secretary Hitchcock should resign, it is understood, but Mr. Hitchcock is believed to be tired of public life and the great responsibilities attached to his office. If he decides not to resign, it is said that he will be succeeded by the Hon. D. E. Thompson, now United States Minister to Brazil. Mr. Thompson is a resident of Nebraska and a millionaire, having large insurance and gas interests. He was one of the hardest workers in the recent campaign. Even should Mr. Hitchcock be persuaded not to retire, it is said that Mr. Thompson will get an important post possibly the ambassadorship to Mexico, succeeding General Powell Clayton.

MANY HEROES

Of General Slocum Disaster to be Given Medals.

New York, Dec. 6.—Tomorrow night a committee of the United States Volunteer Life Saving Association will confer medals on 167 heroes of the steamer General Slocum disaster during which nearly a thousand lives were lost when the excursion boat burned in East River last June. The presentation ceremonies will take place in the Second Battery Armory and Mayor McClellan and several distinguished speakers will be present. Hear the head of the list stands the name of Mary A. McCann, an Irish girl, who while a convalescent on North Brother Island, crawled into the water and saved five young children and girls of her own age. The medals are of silver and bronze and there will also be issued a number of certificates for bravery.
