

NAPHTHA--90 PER CENT

Manufacturer Says His Stove Polish Is Dangerous.

At another of the public hearings which Deputy Fire Commissioner Hugh Bonner and the members of the Municipal Explosive commission are holding at fire headquarters, it was brought out yesterday that many stove polishes contained 90 per cent of naptha. This dangerous preparation was in universal use, it was said. Fifteen manufacturers were present at the hearing.

A. L. Prescott, of J. L. Prescott & Co., manufacturers of stove polish, said that his firm made a stove polish composed of plumbago, varnish and naptha. He explained that as it left the factory it was about the consistency of condensed milk, and contained about 30 per cent of naptha. This was sold to stove manufacturers, who diluted it to suit themselves. Used on cold stoves in warerooms it was not dangerous. The domestic polish, however, put up for household use, in the hands of ignorant or careless servants or others and used on a warm stove was highly dangerous.

"We do make stove polish that is not inflammable or explosive," Mr. Prescott said. "As a manufacturer I am heartily in favor of any action likely to lead to the abolition of this inflammable stove polish from the market. It is largely made out West. They are pushing it vigorously and to keep our trade we have to manufacture a considerable quantity, but it is a dangerous product to handle. We have had several serious accidents at our factory in Newark, and I would be glad to see it go."

"Naptha is much more dangerous than gunpowder. The inflammable vapor which arises from it is invisible and as it is four times as heavy as air, it steals along the floor and seeks out the fire. Its great danger when spread on a stove from which all the fire has not disappeared is perfectly plain."—N. Y. Tribune, March 29, 1907.

GERMANY COULD NOT ACCEPT PROPOSAL

Neutralization Is Dependent On the Failure to Blockade Commercial Ports.

PEACE CONFERENCE ENDS.

CARNEGIE WAS DECORATED WITH THE CROSS OF THE LEGION OF HONOR—TEXT OF THE RESOLUTIONS ADOPTED.

Berlin, April 18.—It is announced that Germany will not accept neutralization as outlined at the peace conference unless there should be no blockade of commercial ports in time of war.

Convention Is Ended.

New York, April 18.—The first convention of the National Arbitration and Peace congress came to an end last night.

The event of greatest interest was the decoration of Andrew Carnegie with the cross of the legion of honor by the French government, represented by Baron D'Estournelles de Constant, in appreciation of his work for peace, and his gift of the palace at the Hague.

Mr. Carnegie, who is president of the congress, gave out a statement as to the results of the congress. Although not so designated by Mr. Carnegie, the statement constitutes a reply to some of the suggestions contained in the letter which President Roosevelt addressed to the congress on its opening day. Mr. Carnegie quotes these statements as "objection" and proceeds to answer them.

The Resolutions.

The congress today adopted its platform or resolutions recommending among other things that The Hague Conference shall hereafter be a permanent institution; that The Hague court shall be open to all the nations of the world; that a general treaty of arbitration for ratification by all the nations shall be drafted by the coming conference to The Hague court of international disputes which can not be adjusted by diplomacy; that the United States government urge on the conference action looking to the limitation of armament; that the conference extend to private property the sea immunity from capture in war.

ALL MAIL BOXES HAVE BEEN PAINTED

Uncle Sam's Property Is Given A Coat of Green.

COLLECTIONS ON SUNDAY.

All the mail boxes in the city, numbering about seventy have received their new coat of green paint and unsightly boxes are now things of the past.

Cards giving the time of collections and deliveries, have been ordered by Postmaster Speckhiser and these will be placed on the boxes as soon, as they are completed. Owing to the fact that boys have in the past tampered with the cards and cut them off the boxes, they will be replaced only once, and it is up to the citizens to protect the cards when they are placed on the boxes. The penalty attached to the offense of tampering with the mail boxes amounts to a fine between \$500 and \$1,000.

Three carriers make a regular Sunday collection now and all letters dropped in the boxes on that day will arrive in time for the Sunday evening mail. Heretofore, only the mail from the most prominently located boxes was collected, but it has been found advisable to make a collection over the entire city on Sunday afternoons.
