The devoutness and deep religious fervor of her life have distinguished Mrs. Parsons always. The funeral arrangements have not been made at this writing.



IS A MUD TURTLE A WILD ANIMAL?

This Question Served as Subject for Hot Discussion In Circuit Court.

OPINIONS DIFFER MUCH.

WHOLE MATTER ARISES FROM THE FACT THAT "TESSIE," THE REID HOSPITAL TURTLE, HAS PASSED INTO STRANGE HANDS.

Is a turtle a wild animal? This question was a subject of a hot discussion among several attorneys at the circuit court. It came up through an amusing incident.

"Tessie," the monster turtle was the ruler of the pond at the hospital grounds until its domain was stolen. "Tessie" is now the property of Frank Egly, a saloon keeper, and it looks as though the big fellow is doomed for the soup. It is claimed that some person after the pond had been let out captured "Tessie" and disposed of her to Egly. One of the hospital officials desired to return the turtle to the hospital and offered Egly \$1.25 for her. The offer was turned down.

The question now is—can the owner of a wild animal which escapes captivity reclaim it? Judge Fox maintains that if the owner can establish the identity of the animal he can reclaim it. John F. Robbins takes the opposite view. He is of the opinion that a wild animal which escapes captivity, and he thinks "Tessie" went out of the pond through the sluice in the bank, is no longer the chattel of its original owner and becomes the property of whoever obtains it after it has escaped from captivity.

Prosecutor Jessup states that "Tessie" is not a wild animal. He states that it has been thoroughly domesticated through its long residence in the pond, and that it regularly appeared each day to be fed by one of Colonel Miller's employees during the time the pond was owned by Mr. Miller, and since then "Tessie" has been fed by one of the attaches of the hospital.
