

## A RULING AGAINST BREWERS IS MADE

Liquor Cannot Be Sold in Dry Territory by Taking Orders by Agents.

Indianapolis, Nov. 29.—Judge Jordan, of the Indiana Supreme court today decided the case appealed from the De Kalb circuit court that the selling of liquor cannot be legally made in dry territory by taking a customer's order for liquor to be delivered through an agent. The Supreme court affirmed the decision of the De Kalb court, which found George Chondel, agent of Diehl Brewing Co., of Defiance, O., guilty of retelling liquor in dry territory and in selling without a license. As the agent for the company, Chondel brought into dry territory the town of Garrett, a car containing beer. The evidence was that Chondel kept liquor in a ice house and doled it out in retail quantities to his customers. This was held retelling.

## COURT INFORMED OF PRIZE FIGHT

Which Was Pulled Off Last Night at Baseball Park at Jeffersonville.

Jeffersonville, Ind., Nov. 29.—Information was filed in the court today by Prosecutor Kopp against the six men who engaged in a boxing contest at the Claysburg baseball grounds last night, violating the law with reference to prize fights. Complaints also were filed against Harry Rodgers, manager of the Tri City Club, who acted as referee, and Eugene Davidson, who acted as a second. Jerry Dalton, Indianapolis, principal in the feature bout, is among those against whom charges were filed. Attorneys for the club will fight the charges.

## ROBBED AT STATION

A Lyceum Agent Loses His Suit Case.

J. B. Alford, a Lyceum bureau agent of Chicago, walked into the Pennsylvania station this morning and dropping his suit case on the floor asked for a ticket to Anderson. When he turned around to get his grip it was gone. Alford rushed to the baggage room door, just in time to see the stranger disappear through it. On going into the station no trace of him could be found. It is believed he boarded the Dayton train which pulled out of the station at that moment. The goods contained in the suit case while not of great value, are worth at least \$100 dollars to the agent. There were several thousand Chattanooga circulars which were to be distributed before he returned to Chicago. He had a week's supply of material in the suit case besides his clothes.

The railroad authorities telegraphed to Dayton but no one was seen on the train who answered the description given of the alleged thief. The police have notified.
