MOTORISTS REJOICE; SPEED LAW INVALID

Lafayette, Ind., Dec. 20.—Henry H. Vinton, judge of the circuit court, held the automobile law of 1909 invalid as far as it applies to the speed of automobiles in cities and towns in the state. In his opinion he says the law is invalid because of its uncertainty, in that it fails to define what is the business and built up portion of a city, and also that it fails to define that part of a city which it describes as other portions, meaning that

portion which is not business or built up portion. His opinion does not touch on the validity of the law as far as it applies to territory outside of cities and towns.

Three persons, Frank Ray, Charles Chambaugh and William Wendling, had been fined for violating the law. They appealed to the circuit court and Judge Vinton was called as special judge.
