

## SEEK VOLUNTEERS TO INVADE SEWERS

Game Association Wants to Find Source of Oil Going Into River.

In case the Wayne County Fish and Game Protective association determines to push the investigation as to the source of the oil supply which is contaminating the waters of White-water river below Richmond, it is probable volunteers will be called for from the ranks of the organization to put on rubber suits and crawl up the 18-inch Main street sewer until they discover where the oil comes from.

This solution was offered but not finally adopted at the meeting of the association in the court house on Thursday evening. There have been innumerable complaints relative to oil killing the fish and tainting their flesh that they cannot be eaten.

Attorney W. H. Kelley, last year president of the organization, is willing to undertake the trip up the sewer in securing evidence as to the source of the oil supply. In order that his testimony would be substantiated, it was decided that the best plan would be to send two others with him.

Nine directors were elected at the Thursday evening organization meeting. The were E. A. Dickinson, H. L. Dickinson and George Deuker to serve for a year; Daniel Scherb, Jefferson Wilson and J. F. Holiday to serve two years, and Ed Cooper, W. H. Kelley and Charles Gross to serve three years. ## FORGERY CHARGED IN A CIVIL SUIT

German Mutual Fire Insurance Co. Seeks to Recover \$175 from J. Noss.

That John Noss, a well known local resident and interested in the electrotyping and engraving business, who has been in embarrassed financial circumstances, fraudulently forged the names of his brother-in-law, George Full, and Sheriff Albert Steen to a note for \$300 is the allegation of the German Mutual Fire Insurance company in a complaint filed in the circuit court on Friday in which demand for \$175 is made.


The action against Noss is entirely civil and prosecuting attorney Charles Ladd declared that no complaint, asking for a criminal proceeding against the accused on the charge of forgery had not been made, criminal action is not anticipated.

Noss several weeks ago in the circuit court was made defendant in a number of civil proceedings filed by a banking institution, in which demand was made for payment of principal and interest on overdue notes. The entire amount aggregated several hundred dollars. Recently property on South Twenty-second street held by the accused was transferred to Triumph Lodge, Knights of Pythias, for \$100 with the lodge assuming a thousand dollar mortgage.

The Mutual Fire Insurance company, which is a Richmond organization, averred that on May 6, 1910, Noss borrowed \$300 from the company's funds. The names of Mr. Full and Mr. Steen were signed as sureties and the company thought the proceeding were regular until a short time ago when demand was made for the money and it alleges Noss refused to pay. Then, it is averred, the company learned of the alleged forgeries of the names of the sureties. It is averred that the defendant knew the names were forged when he borrowed the money.

Noss, the company admits, has paid \$150 toward the indebtedness and the company avers there is now due \$165, consisting of principal and interest. Claims for other proper relief is also made, which makes the company's total demand \$175.
