

ROOSEVELT DEAF IN HIS LEFT EAR, QUITS HOSPITAL

The Colonel Is Determined to Fill Speaking Engagements, However.

NEW YORK, March 4.—The condition of Col. Theodore Roosevelt, who for some time has been a patient at Roosevelt hospital, has progressed so favorably that the former president today left the hospital to take up quarters in a local hotel. Here, it is expected, he will remain for several days under the observation of his physician, and if his convalescence continues as it has for the last week he will go to his home in Oyster Bay.

In the announcement made at the hospital today concerning Col. Roosevelt's condition the fear was expressed that he may be permanently deaf in his left ear as a result of the operation he has undergone. His physicians added that it will be necessary for Col. Roosevelt to rest as much as possible for a fortnight in order that he may recover fully.

Will Speak in Maine. Col. Roosevelt has expressed his determination to fill speaking engagements in Maine on March 28, and his physicians say they believe he will be able to do so, providing he exercises due caution.

The physicians' bulletin issued today says: "For the last four years Col. Roosevelt has intermittently suffered from the after effects of his Brazilian exploration. This acute attack has given us the opportunity to remove the cause, probably completely, and we believe from the rapidly with which the incision has healed that he is in an unusually vigorous condition and that he will speedily be in even better shape than before."

Right Ear to Be O. K. While he was being treated, but not in connection with this condition, he developed an acute infection of both middle ears, which necessitated an incision of both drum membranes. The right ear recovered, and in a few weeks the hearing in this ear will be as good as ever.

"Subsequently . . . the infection spread to the internal ear on the left side, temporarily and probably permanently destroying all hearing functions. It also has destroyed the static functions in this ear, and some months will pass before the compensation for the loss of this function completely takes place."

"In other words, it will be some months before he will recover complete control of equilibrium, or before he will cease to find himself dizzy at a quick or unexpected motion. In consequence, during these months he must be cautious about his activities."

Paris Has Sensation in Arrest of Actress

PARIS, March 4.—The arrest of the actress, Sumey Depay, who has played a minor role at Sarah Bernhardt's theatre, on charges of maintaining relations with the enemy, has caused a sensation, because of the important connections of her alleged accomplices. One of them, an Austrian named Rosenberg, who was prominent on the Paris Bourse and whose Paris bank is under sequestration, fled to Switzerland at the opening of hostilities. He organized a bank and information bureau at Zurich in association with another Austrian named Bettelheim, according to the Matin.

The newspaper says Mathias Erzbacher, a member of the German Reichstag, had a large account with the firm and drew heavily on it to carry on a propaganda in Switzerland.

Another of the accused, Louis Bordier of Paris, formerly director of the Casino at Lugano, was followed into Switzerland by French detectives to the doors of Rosenberg's establishment in Zurich, the Matin declares.

Emile Guiller, husband of Sumey Depay and former manager of Sam McVea, a heavyweight pugilist, had been employed during the war by a manufacturer of artificial limbs to visit military and Red Cross hospitals to take orders for maimed soldiers. Maurice Tremblay, a bank employee and a representative of Rosenberg before the war, also was traced to Zurich, according to the Petit Parisien, and is said to have made mysterious trips along the French coast in an automobile.

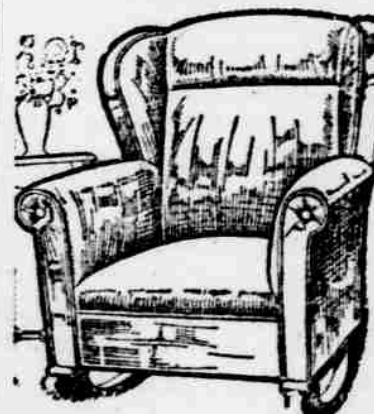
