J., March 24, 1919; discharged April 14, 1919.

Harry Oran Kaiser entered the service June 14, 1918, and was assigned to Company C, Chamber of Commerce Training Detachment, Indianapolis; National Army; embarked from Hoboken, N. J., Aug. 31, 1918, and arrived in Glasgow, Scotland, Sept. 13, 1918; sailed for United States June 14, 1919, and arrived Hoboken, June 28, 1919; discharged June 28, 1919, Camp Sherman.

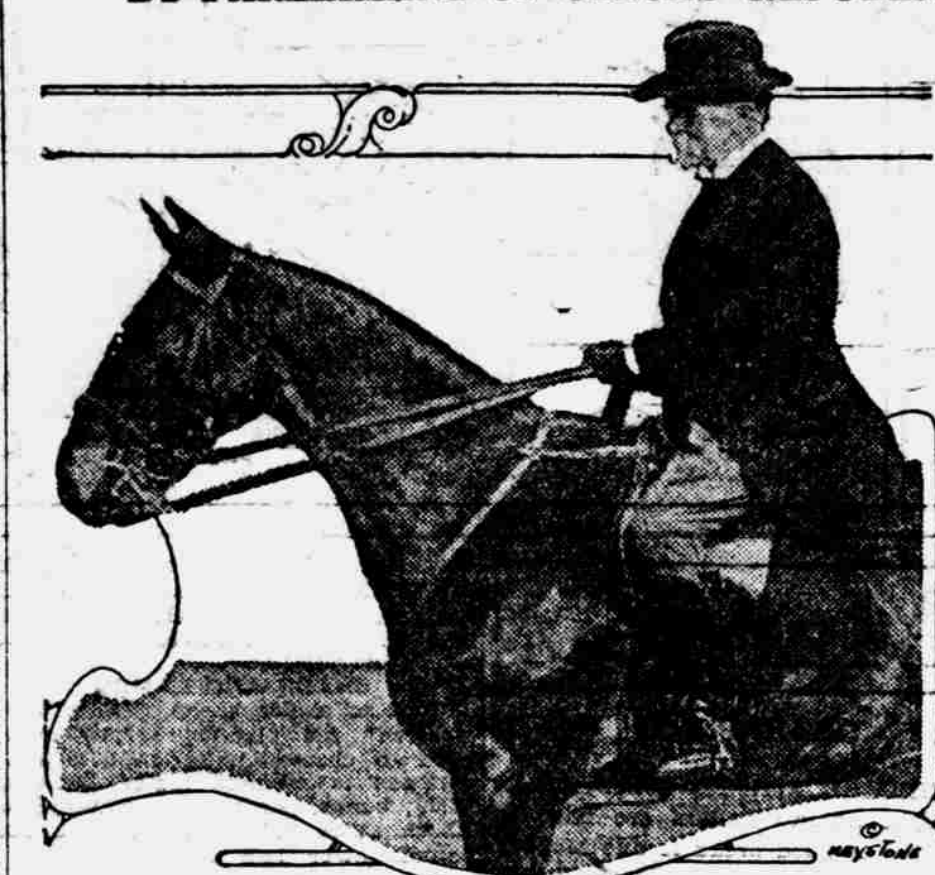

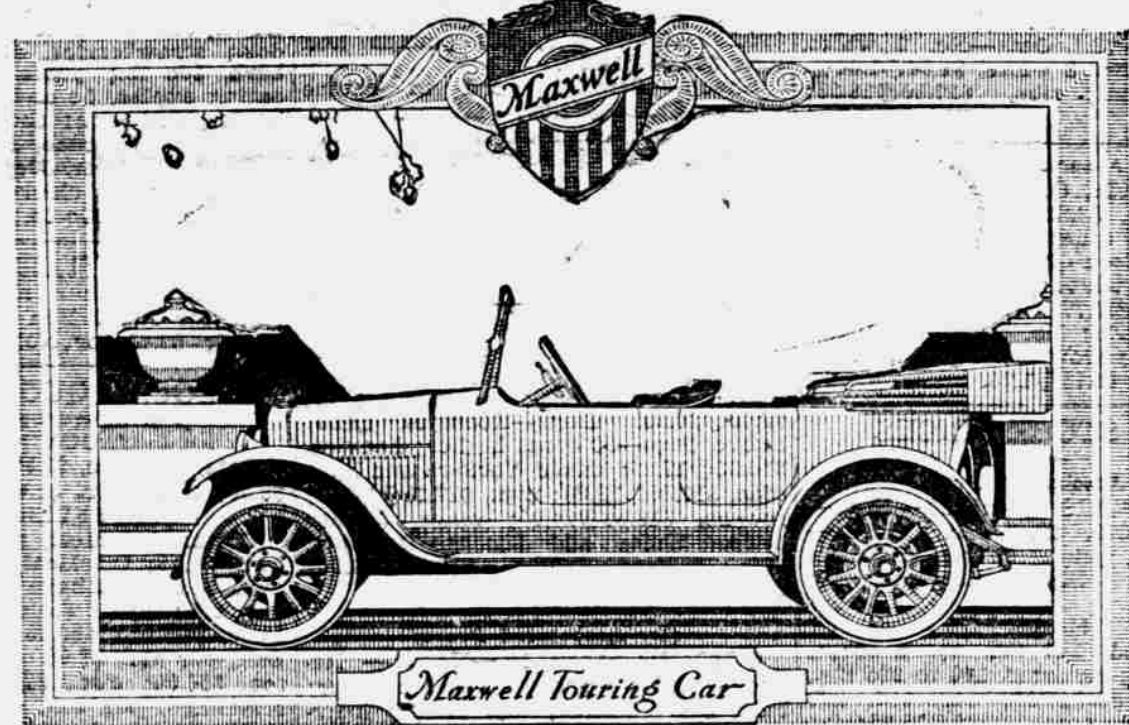
