

THRILLING TALES FEATURED RECORD OF SERVICE MEN TODAY

Frank Rudolph Metzger entered the service April 23, 1917, and was assigned to Battery C, 58th Artillery C. A. C., Regular Army; embarked from Hoboken, N. J., Aug. 26, 1917, and arrived in Liverpool, England, Sept. 15, 1917; in France Sept. 15, 1917; battles, St. Mihiel; sailed for United States Feb. 25, 1919, and arrived at Camp Stuart, Va., March 11, 1919; discharged April 4, 1919, Camp Sherman; corporal.

Claud Evan Waldo entered the service June 3, 1917, and was assigned to Company F, Tenth Regiment, Infantry; Benjamin Harrison, Indiana, and Camp Custer, Michigan; discharged Jan. 28, 1919.

Joe Dalola entered the service March 18, 1918, and was assigned to 20th Company, 50th Regiment, 38th Brigade, Coast Artillery; embarked from Newport News, Va., Oct. 6, 1918, and arrived in Brest, France, Oct. 21, 1918; trained in Brest, France, Hospital Section No. 5; sailed for United States February, 1919, and arrived in New York Feb. 23, 1919; discharged May 14, 1919.

Robert Walden Longman entered the service Oct. 1, 1918, and was assigned to the band, S. A. T. C.

Glenn Otis Mann entered the service Oct. 11, 1917, and was assigned to Company C, 113th Field Signal Battalion 38; embarked from Hoboken, Oct. 5, 1918, and arrived in Liverpool, England, Oct. 17, 1918; sailed for United States April 20, 1919, and arrived in Hoboken, N. J., May 3, 1919; discharged May 23, 1919.

George Elliott Brower entered the service July 3, 1918, as M. M. second class, and was assigned to Ninth Company, 14th Regiment, Naval Reserve; released Dec. 18, 1918, M. M. second class.

Get Over Among First
John Edward Scott entered the service April 14, 1917, and was assigned to Company A, Second Field Battalion, First Division, Signal Corps, Regular Army; embarked from Hoboken, N. J., June 14, 1917, and arrived in St. Nazaire, France, June 21, 1917; battles, French raids Toul sector, Sommeville sector, Antauville sector, Montdidier sector, Cantigny, Soissons, second battle of the Marne, St. Mihiel, Argonne and Meuse, Sedan, Coblenz Bridge lead, Army of Occupation; discharged Feb. 28, 1919, as captain.

Jesse Henry Kenworthy entered the service May 24, 1918, and was assigned to 48th Company, 12th Battalion, Depot Brigade, Q. M. C.; Camp Taylor, Ky., West Point, Ky., and Camp Knox, Ky.; discharged Feb. 1919, corporal.

Lloyd Rowe Garrison entered the service Aug. 23, 1918, and was assigned to 75th Company, Camp Dodge, Iowa; discharged Aug. 27, 1918, Camp Dodge.

Frank Hicks entered the service Dec. 7, 1917, and was assigned to 13th Supply Company, 13th Field Artillery, Fourth Division, Regular Army; embarked from Hoboken, N. J., July 8th, 1918 and arrived in Brest, France, July 18, 1918; sailed for United States, June 18, 1919 and arrived in Hoboken, N. J., June 26, 1919; discharged July 12, 1919.

On First Unconquered Ship.
Charles Henry Spalding entered the service June 11, 1918, Fireman, third class and was assigned to 299th Company, 14th Regiment, Naval Reserve Force; trained at Great Lakes Naval Training Station and Hampton Roads, Va.—Made four trips to Bordeaux on the U. S. S. El Sol as a freighter and horse transport and two trips on the same ship as a troop transport—one of the latter trips being to Brest; this boat is said to be the first ship in the American transport service since the beginning of war on Germany to leave port and cross the Atlantic without a convoy and alone; released from active duty Sept. 11, 1919; Fireman, first class.

Frank Taggart entered the service Sept. 20, 1917, and was assigned to Company C, 113th Field Signal Battalion, 38th Cyclone; embarked from Hoboken, N. J., Oct. 6, 1918 and arrived in Liverpool, England, Oct. 18, 1918; later in France; embarked from Bordeaux, France, April 24, 1919, and arrived in Hoboken, N. J., May 6, 1919; discharged May 22, 1919, corporal.

Walter Delmo Doty entered the service July 31, 1917 and was assigned to Student Army Training Corps, Fiske University, Nashville, Tenn.; discharged Dec. 17, 1918.

Forest Edward Klute entered the service June 26, 1918 and was assigned to Eighth Company, 22nd Tr. Bn., 158th Depot Brigade; discharged Dec. 6, 1918.
