
Mrs. Hickman Dies.

AUTOMOBILES FROM MICHIGAN FACTORY REACH CINCINNATI BY ROUNDABOUT ROUTE, GOING ENTIRE DISTANCE BY WATER

When the towboat Sprague of St. Louis poked its tow of barges laden with more than 400 automobiles into the Cincinnati harbor several days ago, another leg in an odd traffic journey had been completed. The automobiles were built in a Michigan factory, shipped by water to Chicago, then to St. Louis and on to Cincinnati, from which point they will be sent overland to their destinations under their own power. On the return trip the Sprague will fill the barges with 600 automobiles driven overland to Cincinnati from Michigan, but destined for Memphis, Vicksburg and Florida points.




