

# HOTEL, STORE, NEAR GREENVILLE, BURN; STOVE CAUSES BLAZE

GREENVILLE, O., Feb. 25.—The Peters hotel, together with a grocery store and a hardware store owned by Fred Luebking, in the village of West Newton, north of Greenville, were destroyed by fire Thursday morning, with a loss estimated at \$6,500. The fire is supposed to have originated in the grocery and hardware store, caused by an overheated stove. The blaze spread rapidly to the hotel building adjoining before it could be checked.

It was feared for a time that the entire business section of the village would be wiped out by the flames, but a bucket brigade formed by the citizens confined the flames to the two buildings. The hardware store was saved from the hotel, but the entire stock of the store was destroyed. Both buildings were frame structures, the hotel being two stories and the store building one story. An insurance of \$1,600 is carried on the hotel building by Mr. Peters, and \$2,000 was carried on the stock of the store by Mr. Luebking.

**Stucco to Apoplexy.**  
Apoplexy is given as the cause of the death of Markwith McCord, 68, a farmer, who was found lying dead along the roadside just south of the village of New Madison. McCord had been residing for some time past with a cousin, Miss Harriet Mitchell, at her farm two miles south of New Madison. He left there for the village, where he intended to catch a train for Berne, Ind., to visit his two sons. He was apparently in good health when he left. Coroner Hittle was immediately called and pronounced death due to apoplexy. A considerable sum of money was found on the dead man.

**Harris Car Burns.**  
The fire department was called to the corner of Washington avenue and Fair streets recently, where it extinguished a blaze that for a while threatened to destroy the automobile of Robert Harris, of Arcanum. Mr. Harris had been visiting in this city and had started home, when the engine back-fired and ignited the car. The upholstery was badly damaged, together with other parts of the car. The flames were extinguished by the use of chemicals.

**Stocker Sues for Divorce.**  
Suit for divorce was filed in common pleas court here by C. E. Stocker, of Greenville, against his wife, Zueling Stocker. The Stockers were married in Greenville in August, 1912. The plaintiff alleges that his wife has been guilty of gross neglect of duty, has failed to attend to her household, and has treated him cruelly. He asks for absolute divorce, custody of their four year old son, and that his wife be barred from any interest in his property.

**Has Peculiar Theme.**  
"Personal Experiences of an Erratic Woman," was the subject of a lecture by Mrs. Ada Dodd Poole, of Dayton, at the Memorial Hall, Thursday. The lecture was the fourth of a series given under the auspices of the ladies club of this city. A good attendance of Greenville ladies was present.

**Local Club Banquets.**  
Over two hundred persons attended the annual banquet of the Greenville Commercial club, held at the Elks' Home, West Third street, this city, recently. The wives of the members were guests at the affair.

**Snell Petition Granted.**  
At a hearing before the Darke county commissioners here yesterday, petition for the Snell ditch was granted. A hearing on compensation, etc., will be held March 12.

**Allegation is Charged.**  
Suit for damages in the sum of \$5,000, for the alienation of his wife's affections, has been instituted in common pleas court here by William G. Miller, against John and Jennie Howell, his wife's parents. Miller asserts that he was married to Lillian Howell on January 25, 1920, and that they lived happily together until January 6, 1921, when she left him.

He alleges that the defendants conspired to deprive him of the comfort, service and society of his wife, and to this end circulated false reports concerning his character, thereby causing her to leave him.

**Files Friendly Suit.**  
A friendly suit to determine the construction of the will of the late Samuel O. Westerfield, prominent banker and business man of this city, who died last November, was brought in common pleas court here. The suit was brought by Flora M. Westerfield, executrix of the will of the late Samuel Westerfield, against Flora M. Westerfield, Mary Etta Gilbert, Walter Gilbert and Robert Gilbert, the heirs. The court is asked to construe the will so that the executrix may properly carry out its provisions.

**Spain Orders Gambling STOPPED AFTER MARCH 1**  
MADRID, Feb. 25.—Gambling throughout Spain will be suppressed from March 1, according to orders issued by the minister of the interior. The legal code forbids all gambling, but permission has been granted widely to clubs in return for contributions toward the support of the poor, which lately have not been sufficiently generous.
