

**PARIS IS AWAITING
OUTCOME OF DISPUTE
OVER PAPER'S POLICY**

PARIS, March 3.—All Paris is awaiting the outcome of an effort by Louis Lazarus, retiring editor in chief of the *Figaro*, to obtain satisfaction from the new editors of the newspaper for the initial editorial to which he took offense.

M. Lazarus first challenged Alfred Capus, but the latter, who is 64 years old, told M. Lazarus' seconds he had long ceased to be even amused by such challenges and that, anyway, it was customary that the younger man should be challenged when two were jointly involved referring to Marquis Robert De Flers, aged 50, his co-editor.

Later when the Marquis heard of the incident, he promptly sent his seconds to M. Lazarus, who has not yet replied, as far as known. Both M. Capus and the Marquis De Flers are members of the French academy, and the former is well known as a dramatist.

The *Figaro*, an influential morning newspaper was taken over on Feb. 26 by M. Coty, a perfume manufacturer, and a group of associates. When the purchase was first announced M. Lazarus attacked the new proprietor in bitter terms, and described him as a radical socialist belonging to the "party of which Caillaux was formerly the acknowledged chief." At the same time Edouard Calmette, son of the former director, Gavon Calmette, who was shot dead by Mme. Caillaux, announced his resignation as general secretary of the *Figaro*.

**DORMITORY BURNS
AT OXFORD COLLEGE**

OXFORD, Ohio, March 3.—Fire originating in an overheated furnace destroyed Fenton House, a dormitory for women, and endangered the lives of many young women and faculty members Thursday morning.

Dr. Clara Schreiber, faculty member, was aroused from her slumber and escaped in scanty attire. Miss Marcia Watkins, Patahala, Ohio, distinguished herself as a heroine when she carried Miss Rodman Hayes, Bloomfield, Ky., down a flight of stairs. Miss Mary Lake, of Springfield, Ky., and Miss Ruby Richardson, Cincinnati, were assisted by firemen from a second story window. They were nearly suffocated by smoke. Three others escaped down a ladder held by Louis Rockhold, a workman.

A number of young women lost all their personal belongings, although nearly all the furnishings were salvaged.

Members of Delta Upsilon fraternity, Miami University, whose chapter house is across the street from Fenton House, assisted in saving property. Miss Marie Leucuyer, professor of French, lost heavily, as did also Miss Madeline Bryant, violin instructor.

Two valuable violins, however, belonging to Miss Bryant, were saved.

**WOMAN ARRESTED
IN LIQUOR PROBE**

Mrs. Loréna Dunham, wife of Alfred Dunham, was taken to the Home for the Friendless Friday morning, to be held pending further investigation of charges that she was violating the liquor law. Mrs. Dunham was arrested at her home Friday morning. Officers had found a coil and cooler for a still in her garage at 2 o'clock Friday morning. Search of the house when Mrs. Dunham was arrested brought forth a tin can which had served as the boiler for the still.

Mrs. Dunham's husband, Alfred Dunham, was arrested Jan. 30, fined \$100 and costs and given a 30 day sentence to the penal farm, on conviction of violation of the liquor laws. The still he had at that time was confiscated and destroyed.
