### Busy Docket In Newton.

Judge Hanley and Court Stenographer Sigler went to Kentland today to reopen the Newton circuit court, which will have a busy session the closing two weeks of the term.

This week is being tried the cutting scrape of the two Elijahs, Arch and Orin, who last fall almost killed Tom Dowling, near Morocco. Dowling was ditch commissioner and went to the home of the Elijahs to collect assessments and was almost murdered. He was hit over the head with a spade and cut in several places with a knife, and the only thing that saved his life seems to have been a pocket dictionary in his left vest pocket. The knife had passed thru this little book and made a wound in his left breast over the heart. A great many people think the assault was provoked and the evidence is apt to develop this, the Elijahs having been very reticent since the occurrence.

This case will probably take most all week and then the hog stealing case will go over to the next week, and there are enough other cases on the docket to make the ensuing two weeks very busy ones.

### Goodland 17; Rensselaer 9.

Our high school boys got the short end of the basket ball game in Goodland in more ways than one. They should have been entitled to the referee, but were edged out of this because they had not notified Goodland four days ahead who the referee would be, as provided by the rules, and then Mr. Phillips, the Goodland eighth grade teacher, who refereed the last halt, is alleged to have overlooked repeated fouls committed by the Goodland players, and to have given Rensselaer some very ragged decisions. The room in which the game was played was very small and the baskets two feet lower than is required by regulation and the ceiling so low that Rensselaer was placed at a great disadvantage. Of the fourteen fouls called against the Goodland team, Woodworth only succeeded in making three baskets. The other points made by Rensselaer were 2 field goals by Gowland and one by Long. The conduct there of the Rensselaer boys is vouched for by Tillman and Dean.

Since returning home Mr. Tillman, who was acting manager of the basket ball team at Goodland, Prof. Gray having been unable to go, learns that Goodland had been duly notified by Mr. Gray who the referee would be, and it seems that Goodland had taken advantage of Mr. Gray's absence to deny that they had been notified. The teachers say it was the rawest deal they have ever had served to them during their connection with athletics.

### Mis from Hazing.

Raymond Taylor, a sixteen-year old pupil of the Eugene Field School, in Chicago, is dead, a victim of hazing. He was hazed by two of his schoolmates about ten days ago, and, although he attended school until last Tuesday, he did not recover from the effects and died of spinal meningitis. The police and the school board are investigating. The hazing which cost the life of young Taylor consisted in what the boys at the school call the "royal bumpers." Two of his schoolmates seized the boy, one taking his head and the other his feet, and, holding his hands so he could not protect himself, they bumped him on the brick pavement of the schoolyard.

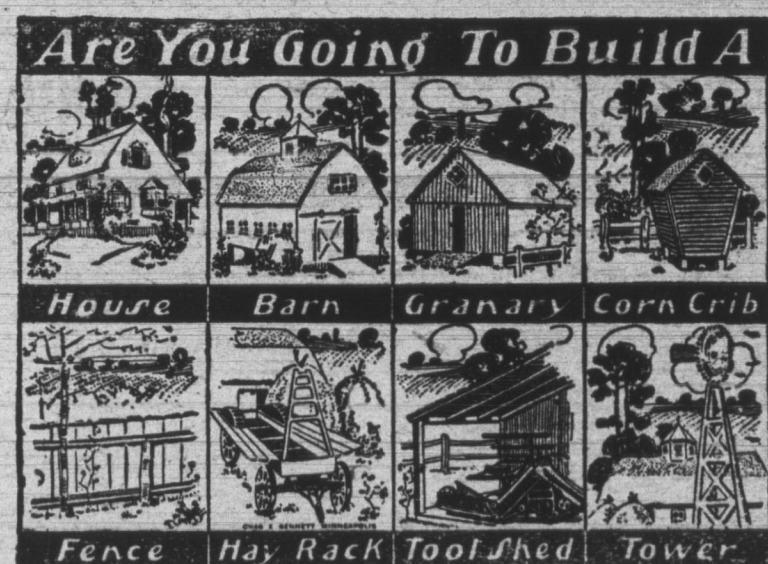
