Some Political Suggestions.

The convention for the selection of delegates to the republican national convention is drawing near. It will be held next Tuesday in Rensselaer and will probably draw together a great many of the party leaders of the district. To all appearances there are only three candidates and as two of them will be selected there is not very much of a scrap on hands. The three candidates are, George Ade, now announced as a safe administration man; Will R. Wood, of Lafayette, state senator and prominent lawyer and politician; and A. K. Sils, of Monticello, also well known, and a formidable candidate whenever he goes after any position where the political game is played.

It seems tolerably certain that Will R. Wood is "agin" the administration, and that he can not be counted upon to vote the will of the people, that is, to support Taft, should Fairbanks fail to be nominated. It may be that Senator Wood is not rightly figured, but those who have watched his training politically are of the opinion that he is pledged to pass Taft up. Every delegate should smoke him out and make him state just what he will do, and then if he is elected a delegate, hold him responsible for doing it. Mr. Sils, smooth, oily and still magnetic, will probably come out with a statement of his intentions if he stays in the race, and if he is right, then he should be supported by all delegates who are not willing to back up on the Roosevelt policies. There would be plenty of room for another candidate, if he would announce himself firmly for the administration, and even then he came out a little late, he would probably get the votes. This candidate is apt

to develop, and the Republican would like to see him get busy at once, whether he comes from Jasper county or not. Word reaches us from both Benton and Newton county that unless Will Wood is for the administration his best friends will be against him.

This should be a good convention and Jasper county republicans that like spirited conventions should get in to attend it. It will be held in the afternoon in the opera house.

In the morning of the same day occurs the county reorganizing convention. There are twenty delegates to this convention, and while it seems reasonably certain that there will be no opposition to the selection of Secretary Moses Leopold as chairman, the convention should be fully attended in order that the action may be ratified by a full vote.

In this connection we wish to urge that republicans make a special effort to get out to the conventions Saturday that will elect committeemen. It is very important that good men be chosen to look after the party interests in each precinct and their selection should be approved by all republicans who should be certain to attend the organizing conventions. These will meet Saturday of this week in the regular meeting places unless otherwise announced.

Republicans everywhere should participate in this early organization.
