

Notice To Bidders

Notice is hereby given that the Board of Commissioners of Kosciusko County, will, on Monday, June 5, 1950, receive bids for coal to be supplied as follows at the County Home, County Jail, and the County Court House for the year, 1950.

Between 150 and 200 tons of stoker coal for the County Home to be delivered as needed.

Between 80 and 90 tons of stoker coal for the County Court House.

Between 40 and 50 tons of stoker coal for the County Jail.

All coal to be treated and all coal to be free-burning, non-coking coal and guaranteed for use in stokers.

All bids call for delivery of coal to designated bins and all contracts shall expire December 31, 1950.

All bids must be on file by 1:00 p. m. DST, June 5, 1950, and each bidder must accompany his bid with a bidder's bond subject to the approval of the Board and equal to the bid.

Sale Approved.

Sale of personal property in the estate of Hannah M. McClintic for \$82.50 cash by R. Leon Connolly, the administrator, has been approved in circuit court. The administrator has filed an action for authority to sell real estate to create assets to pay obligations of the estate, the proceeds from the

sale of personal property being insufficient for the purpose. The real estate includes Lots 9 and 10 in Block 3, Ketting & Ketting's addition to Syracuse, valued at \$2,800 exclusive of liens, including that of \$1,336.50 held by the county welfare department. Named as defendants in the action include the welfare department and three heirs, a brother-in-law, Perry Clemans, nephew, E. Lester Clemans, and a niece, Helen Beauchamp.

File Demurrer.

The county commissioners, auditor and treasurer Friday filed demurrers in circuit court to an action by which Archie Baumgartner, of Milford, seeks to force the county to pay him for legal advertisements published without instructions on grounds that his paper, the Milford Mail, is the only Democrat paper in the county. All of the defendants contended that the complaint did not state facts sufficient to constitute a case.

The commissioners contended that the court did not have jurisdiction since it did not appear that there was any contract entered into by which the county agreed to pay for the alleged services rendered and that there can be no appeal from a decision of the commissioners or any action against the county for services rendered voluntarily.

The commissioners also set out that the complaint did not allege the services were rendered on order of anyone authorized to obligate the commissioners, that the Milford Mail was generally known to be or had declared its politics by editorial comment or otherwise, or that it had a net paid circulation of not less than 2 per cent of the population of the county by the last published census.

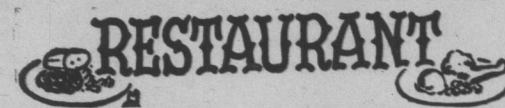
