Town Attorney Leon Connolly reported this week that a tentative date has been set by Judge Frederick H. Rakestraw for the hearing on the motion to vacate the last Order Book Entry on the Stiefel Grain Company case. The tentative date has been set for Friday 31 May at 2:00 p. m. in the circuit court at Columbia City.

The order book entry referred to was made in May 1956 and required the Stiefel Grain Company to install the necessary air scrubber equipment for the elimination of odor and residue and allowed the company until 1 December 1956 for perfecting the operation. Inasmuch as various circumstances prevented Stiefel Grain from fulfilling this order, the motion was entered by the Town Attorney to vacate the order.

If the court sustains the motion, Connolly stated, the case will be ready for trial. If the motion is lost, he added, other procedure will have to be considered.
