UNEMPLOYMENT CLAIMS DROP

Unemployment insurance claims dropped another 7.6 per cent last week to a 33,524 total. Except for several one-week inventory closings, involving some 1,400 employees altogether, no layoffs were small scale. Lewis F. Nicolini, director of the Indiana Employment Security Division, said.

Outdoor industries continued to expand employment and steel mills were adding workers. Numerous footwear, clothing, and automobile industry workers were recalled.

Mr. Nicolini said the claims total last week was about 10 per cent under that for the same week last year when 37,225 Hoosiers filed for unemployment insurance.

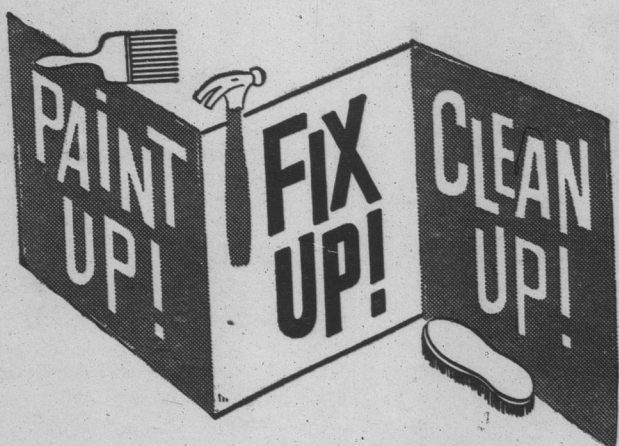
