"That the constitution and all laws of the

United States which are now locally inappli-

cable, shall have the same force and effect

within the said Territory of Nebraska as

elsewhere within the United States, except

the eighth section of the act preparatory to

the admission of Missouri into the Union,

approved March sixth, eighteen hundred

and twenty; which being inconsistent with

the principles of non-interference by Con-

gress with slavery in the States and Terri-

tories, as recognized by the legislation of

eighteen hundred and fifty, commonly called

the Compromise measure, is hereby declared

inoperative and void, it being the true in-

tention and meaning of this act, not to legislate

slavery into any Territory or State, nor to
