Extract of a letter from Canada.
"The French militia have been turned out: the second brigade on Tuesday last. The commander called on those he chose; they being embodied, he called for every fifth man to step out from the main body. His call was not obeyed in the least. Some said they would not step out without the rest; and some made bold to say, they would not take up arms against the Americans, but would join them when they chose. Forty who said they would join the Americans were committed for mutiny, and will have their trial to-morrow."

Extract of a letter from Fredericksburgh, dated October 21.

"I wrote you on Monday last, informing of the dreadful calamity that has visited this place. I could not at that moment of alarm, state accurately the extent of the mischief; it is now ascertained that at least two hundred houses of different descriptions have been destroyed—many of their former occupants are yet without a dwelling.

"The whole loss is estimated at four hundred thousand dollars.

DENMARK.

Copenhagen Aug. 20.

The prince Royal has given orders rather to burn the fleet, in case of extremity, than to suffer it to fall into the hands of the enemy. When Mr. Jackson, it is said, gave him twelve hours to take his final resolution, he did not employ so many seconds in positively rejecting his propositions.

LONDON, Sept. 1.

An order of council was published in Saturday's Gazette, prohibiting all vessels belonging to his majesty's subjects from entering or clearing out for any of the ports within the dominions, of the king of Denmark until further orders, that a general embargo be laid on all Danish vessels in English ports; and that Da-

nish vessels fallen in with on the high seas be detained.

FIRE;

AT FREDERICKSBURGH,
From the Virginia Herald of Wednesday.

On Monday, at 12 o'clock the house formerly belonging to Mrs. Carter, in this town, was discovered to be on fire. The corpse of Mr. William Standard, the more recent proprietor, had not been sent to its earthly home, when a sick and mourning family were driven by a new calamity, with the remains of a parent and husband, from the solitude of their sorrows to weep under the next hospitable roof, over their complicated misfortunes.

The house was on an eminence and a strong wind from the north west blew the flames into the body of the town.

In the course of a few hours three of the best improved squares, with part of two others, were stripped of all their improvements. The rapidity of the fire, in the horrors of its devastation

through houses highly combustible from the operation of the late drought, the consternation that prevailed destroyed concert & presence of mind

in the most of those who were laboriously active, incompetency of the engines to perform their offices with full effect, prevented many of the sufferers from saving a great

proportion of their moveable property.—The upper Tobacco Warehouses with all the tobacco stored, were consumed. A flake of burning matter was thrown on the roof of the bankhouse, which

flood at the distance of two streets from the general conflagration, and so furious was the progress of the flame, that

all the books, papers and money in the vaults were, of necessity, exposed, during the whole of the fire to its action, but have since been recovered entire.

This awfully afflicting event had bereft many families, some in disease, at the entrance of winter, of their only shelter and of their all.

The woes of the comfortless and of the suffering, which prevade a great part of Fredericksburg call aloud for contribution from the opulent.

The inhabitants of this town were lately liberal in their relief to the wretched of Norfolk. A plan has been organized to furnish the benevolent of the sister towns in Virginia, and of the neighboring country, with an oppor-

tunity of enjoying that luxury which a poor bosom feels in giving charity where merit and distress combine to claim it.
