

eight hours, which was refused, only two hours granted when he agreed to surrender according to the summons sent in, on the basis of the garrison becoming prisoners of war.

I have now the satisfaction of acquainting your lordship that these preliminaries being acceded to, as soon as the admiral landed in the morning, colonel Long, adjutant general, and captain Cockburn, of the royal navy, were appointed to negotiate the further articles of capitulation, which I have now the honour to enclose. They were ratified about three this morning, when detachments of the royals, on the right, and his majesty's 71st regiment, on the left, took possession of the gates of the town. The garrison will march out tomorrow, and will be embarked as speedily as possible.

I may now congratulate your lordship on the fall of a place so indispensably necessary to our future operations, as so large a proportion of our force being required to carry on the siege with that degree of vigour and dispatch which the means of defence the enemy possessed, and in particular his powers of inundation (which was rapidly spreading to an alarming extent) rendered absolutely necessary.

Having hoped had circumstances permitted to have proceeded up the river at an earlier period, I had committed to sir Eyre Coote the direction of the details of the siege, and of the operations before Flushing, and I cannot sufficiently express my sense of the unremitting zeal and exertion with which he has conducted the arduous service entrusted to him, in which he was ably assisted by lieutenant colonel Walsh and Offey, attached to him as assistants in the adjutant and quarter master general's department.

I have every reason to be satisfied with the judicious manner in which the general officers have directed the several operations, as well as with the spirit and intelligence manifested by the commanding officers of corps, and the zeal and ardour of all ranks of officers,

CHATHAM.

Turkey, June 30.

According to accounts from Moldavia, the Russian army, in conjunction with the surviving insurgents, has made great progress on the right bank of the Danube, and already taken possession of the greater part of Bulgaria. They find as usual, great support from the Greeks, a decisive battle with the Turkish army is expected near Adrianople.

The Porte, according to its usual custom, has declared against Russia a war of religion; the holy green standard of Mahomet has been raised at Constantinople by the Musti & all the Mussulmen required to take up arms. But the fall of the active Mustapha Bairaktar, the suppression of the feymens, soldies exercised in the European manner, which was effected by the mutinous janissaries, the anarchy which prevails throughout all the provinces, the mutual jealousies of the Pachas, and other evils under which the Turkish empire has long groaned, threaten to bring on it a great catastrophe.

SUICIDE.

A report has arrived in this place which we believe may be depended on, that governor Lewis, formerly captain Lewis, who explored the Mil

four, with capt. Clark, who lately passed thro' this place, as mentioned in our last, has, after many attempts to put a period to his existence by shooting himself, at length completed the horrid deed, on the road between the Chickasaw nation and Nashville, by cutting his own throat. We have not heard, nor can we determine what could have been the cause of this dreadful catastrophe.

Letters were yesterday received from Rotterdam, to the 13th inst. One of them mentions that gen. Armstrong on the part of the government of the United states, had arranged with the ministers at Paris a commercial treaty, the conditions of which were agreed and determined; and it remained only for the ratification of the ruler of France and the american president. The letter adds that one of the duplicates had been forwarded to Napoleon for his approbation and signature.
