### THE WESTERN SUN.

VINCENNES, JULY 28, 1810.

The post rider from this place to Kaskaskia, was, some weeks past, killed on the road, and his body staked down in the bottom of a creek.—The mail has not yet been found.

There is also a report of another man having been killed on the same road sometime last week.

### BANKS.

Mr. Blodget of Washington city, has recently obtained a complete and accurate return of all the Banks in the U. States. On the first of April last, the number of Banks was one hundred and three, and of the branches, thirty, making in all one hundred and thirty three. The nominal capital of the whole of these banks exceed fifty eight millions of dollars.

### FROM ENGLAND.

A London paper of May 19, has been received in Boston. The princess Amelia, lay at the point of death on the 18th May, and the king was then in good health, having occasionally watched with his daughter. The report this morning of the death of the king we think is premature.

Boston Palladium.

On Tuesday last, Theodore Count Pahlen, minister plenipotentiary and envoy extraordinary to the United States, from his majesty the emperor of all the Russias, was presented to the president of the United States, to whom he delivered his letters of credence.

Count Pahlen is accompanied by Mr. Polletta as counsellor of legation, Mr. Ivanoff as secretary of legation, and Count Nicolas Pahlen, attached to the legation.

### LONDON, May 5.

Private letters from Amsterdam express the utmost alarm and anxiety for the future fate of the oppressed inhabitants of Holland, which all the fair promises of Bonaparte cannot remove. It is stated, that while a regard for the independence of that country is professed by the French government, every port and creek is filled with French soldiers and French custom house officers. Not a less force than twenty thousand men, now occupies the ports of Holland. Their head quarters are at the Hague.—It is suspected to be the present policy of Bonaparte, to oppress the Dutch so grievously, that they may at last beg the incorporation of their country with France as a favour.

### PHILADELPHIA, June 29.

Spanish America.—Yesterday arrived at the Lazaretto, the schooner Three Friends, Capt. Schuyler, 28 days from Ligua. On board of this vessel is Don Juan Edwardo, of Carracas, with dispatches for the deputies lately arrived in the U. States, from that province.

This gentleman informs that the government of Carracas is at present vested in a junta, consisting of five persons, who exercise legislative, executive, and for the present likewise judicial functions.

The following ministers have been appointed; one of internal finances, one for foreign affairs, and one of war and navy.

Courts of judicature are not yet regularly organized, nor is the militia yet systematized. Commercial regulations are undergoing a favorable change for the United States.

The present government is considered as temporary, and to continue till all the departments of the province of Venezuela shall have ratified the measures adopted at Carracas, which it is supposed will soon be the case. There are only two departments that of Maracaibo, and Coro, which have not yet joined in the late important change of government.

The deputies from the departments of Gavira, Vargas, and Cumana, co-operate with the Junta at Carracas.

There appears to be no foundation for the report that an extra session of congress will be called.
