VINCENNES, SEPTEMBER 1, 1812.

Recent accounts from Detroit, state that gen. Hull had been under the necessity of recrossing the river, and was posted in that town—that the British were posting themselves on one side, and the Indians, in considerable numbers, were gathering about him on the other—and that his rear was intercepted, and no convoy could reach him.

Considerable reinforcements have been ordered from Kentucky and Ohio—the whole under the command of governor Harrison, who a few days since received from governor Scott, a commission of major, gen. by brevet, in the Kentucky militia. This appointment it is understood will be highly approved of in Kentucky and Ohio.

Nothing but speedy and decisive measures will relieve our army at Detroit—the reinforcement now on its march, is gallant and enthusiastic in the public cause, & conducted by HARRISON, will do whatever can be done.

Since the piece from the Argus, extra. was in type, we have learned, that instead of col. M<sup>r</sup>Arthur, it was col. Miller, who commanded in the affair of the 9th—he drove the British and Indians two miles before him—a troop of dragoons (from Ohio) was ordered to charge, and would not!! O shame!

From Tennessee we learn the Creek Indians have lately killed a family, and that the militia of that State was again ordered out.

We have information from various sources, and which we think entitled to belief, that the British and Indians have taken possession of Brownstown, about 14 miles on this side Detroit, and that the communication is entirely cut off, and that the last effort that went out with beef and other provisions had stopped in the wilderness, & would not proceed until further reinforcements arrived.

## PROROSALS

For carrying Mails of the United States on the following Post Roads will be received at the General Post office in Washington City, until the 29th day of August next inclusive.

### IN INDIANA.

32. From Jeffersonville by Charlestown, Madison, and Laurenceburg and Franklin c. h. to Wayne c. h. once in two weeks. Leave Jeffersonville every other Monday at 6 a. m. and arrive at Wayne c. h. on Wednesday at 6 p. m.—Leave Wayne c. h. every other Thursday at 6 a. m. and arrive at Jeffersonville on Saturday by 6 p. m.

### NOTES.

1. The post matter general may expedite the mails, and alter the times for arrival and departure at any time during the continuance of the contract, he previously stipulating an adequate compensation for any extra expense that may be occasioned thereby.

2. Fifteen minutes shall be allowed for opening and closing the mail, at all offices where no particular time is specified.

3. For every thirty minutes delay (unavoidable accidents excepted) in arriving after the times prescribed in any contract, the contractor shall forfeit one dollar; and if the delay continues until the departure of any depending mail, whereby the mails destined for such depending mail lose a trip, a forfeiture of double the amount allowed for carrying the mail one trip shall be incurred, unless it shall be made to appear that the delay was occasioned by unavoidable accident; in which case the amount of pay for the trip will, in all cases, be forfeited and retained.

4. Persons making proposals are desired to state their prices by the year. Those who contract will receive their pay quarterly—in the months of February, May, August and November, one month after the expiration of each quarter.

5. No other than a free white person shall be employed to convey the mail.

6. When the proposer intends to convey the mail in the body of a stage carriage, he is desired to state it in his proposals.

7. The post master general reserves to himself the right of declaring any contract at an end whenever one failure happens, which amounts to the loss of a trip.

8. The contracts are to be in operation on the 1st day of November next, and continue until December 31, 1814, for the routes No. 1 to 33, inclusive, & for the other routes to December 31, 1813.

ALL BRITISH SUBJECTS within the United States are required forthwith to report to the Marshals (or to the persons to be appointed by them) of the respective states or territories within which they may reside, their names, their age, the time they have been in the United States, the persons composing their families, the places of their residence, and their occupations or pursuits; and whether, & at what time, they have made the application to the courts required by law as preparatory to their naturalization—and the Marshals, respectively, are to make to the department of State, returns of all such British subjects with the above circumstances annexed to their names.

## OBSERVE THIS!

THAT in future any person or persons trusting or crediting soldiers that are stationed at fort Knox, without they have a written permission, signed by the commanding officer, may rest assured that they shall receive no consideration for any thing which they may have sold contrary to the true intent and meaning of this notice.
