The last mail furnishes us with nothing new.

Nashville, December 21.

Gen. Jackson writes to the governor that on the 12th inst, general Cocke with 1,450 men formed a junction with him, that on the 13th the two regts. of volunteer infy. would leave his camp for Nashville to be discharged by the governor if he felt himself authorized, that on the 14th he would march for the purpose of meeting the enemy, who had embodied about 45 miles from where the battle of Talladega was fought, supposed by the general to be from one to two thousand strong, and expected to have an engagement with them on the 18th or 19th inst.

The British at Pensacola.

The following letter from colonel Bowyer, to gen. Claiborne, was forwarded by express from him to his excy. governor Blount.—It puts us in possession of news that we have long anticipated.

Mobile, November 26.

SIR—I have this moment received from capt. Alexes, commanding the navy at Mobile Point, a letter stating positively, a large British expedition has arrived at Pensacola, consisting of 7 sail of vessels and 2 bomb vessels. That some brigs have 200 men on board—I shall leave this by 12 o'clock for the Point with all the troops I can possibly spare from this post, with a determination to defend this post to the utmost. This will leave the Mobile weak and exposed. I have written to Lt. col. Ruffel, requesting him to fall back to this place with the 5d regt.

Should he comply, I think we will be able to save the country, but should he not feel himself justified to give up his present objects I fear the whole of this country will be lost. Should you have an opportunity, pray write to colonel McKee, and give him this information. The communication to Pensacola by land is cut off by a large body of Indians.—I am, sir, in haste, yours &c.

Gen. CLAIBORNE.

Augusta, November 12.

Letters from fort Stoddert inform us, that the hostile Creeks have all left the nation, and have retired for protection, against the approaching storm, to their friends at Pensacola. General Flournoy is now at fort Stoddert,* at the head of 3000 regulars, and is determined to pursue this ferocious & mis-

guided band to their present retreat. Should the Spaniards attempt to defend them, our army & general are able and determined to take satisfaction of the accessory as well as principal, without we hope waiting for an act of congress, &c.

New-York, December 2.

Major general Hampton, colonel Randolph, major Lee, capt. Randolph, and several other officers arrived in this city yesterday, in the steam boat from Albany.

Yesterday a dinner was given to major general Harrison, at Tammany Hall.

Albany, November 30.

At the last dates from the army, general Wilkinson was so seriously indisposed, as to render his recovery doubtful.

The order for Hampton's division of the army to march to St. Regis has been countermanded except as it respects the second battalion of the 11th, and a company of the 5th.

M'Arthur's brigade has arrived at Sacket's Harbor, on board the squadron, from fort George, the enemy having abandoned Burlington Heights.

Generals Wilkinson and Lewis are said to be on their way to this city.

The United States frigate, President, commodore Rodgers, went to sea from Boston, on Tuesday the 30th of November.

Raleigh, October 4.

The sales at Newbern of the prize goods of the Snap Dragon privateer, commenced on Monday last, and closed on the Friday evening following. About 500 merchants were supposed to be present, assembled from all the towns from Boston to Augusta.—The sales we understand, averaged about twelve dollars for each pound sterling invoiced, the sales amounted to near four hundred thousand dollars.

With the approbation of the government of the United States, Thomas S. Hinds has been appointed by col. Thomas Barclay, commissary general of British prisoners in America, agent to superintend the furnishing and supplying clothing for the prisoners taken by commodore Perry on lake Erie. It appears by mr. Hind's instructions, that neither these prisoners, nor those taken by gen. Harrison, will be exchanged this winter.
