U. S. Ordinance Department,  
Washington City, Nov. 19, 1814.

PROPOSALS will be received at the United States Ordinance Department, Washington city, from companies or individuals, in any section of the southern or western states, for the supply of the following articles:

### Muskets with Bayonets.

A wiper to each Muskets and twelve screw drivers and bullet screws to every hundred Muskets.

### Rifles.

With each Rifle a wiper and bullet mould, and eleven ball screws and screw drivers with every hundred Rifles.

Patterns for the Muskets and Rifles will be furnished; and the articles, when completed for delivery, will be inspected by an officer to be appointed by this department. Satisfactory security will be required for the faithful performance of the contracts.

The proposals will state the prices, and the number agreed to be furnished in specified periods; as also the places of delivery.

Contracts for an immediate, or early supply are desired; but they will also be continued for certain quantities throughout the succeeding year or years, as may be agreed upon.

In any district where there may be an officer of the Ordnance department stationed, the proposals may be made through him if preferred.

### GENERAL ORDERS.

ALL field and company officers who are absent from their corps, by furlough or otherwise, except those on particular duty, and such as are designated for the recruiting service, will forthwith repair to their respective regiments and corps.

The adjutants general of the several districts and divisions, and the commandants of regiments and corps, will transmit to this office, to be laid before the secretary of war, the names of all officers who fail to report themselves for duty conformably to this order.

The names of those who report absent by reason of indisposition, will also be transmitted, designating such as are accompanied with a certificate of inability.

All officers arriving at the seat of government will immediately report themselves at this office, that the secretary of war may be advised of their orders and addreses; and in like manner on their arrival at the head quarters of a district they will report at the adjutant general's office of each district.

### GENERAL ORDER.

ALL Surgeons on furlough, as well as those of militia in the service of the United States, as the Medical staff of the army, will forthwith repair to their respective hospitals, regiments, corps and stations.

The troops are reported sickly at many posts, and no neglect will be suffered in the Medical staff.

Generals commanding districts, and officers exercising separate command, will be particularly attentive to this sacred duty.—They will cause all complaints to be promptly investigated. Defaults will be punished in an exemplary manner.

Good and convenient hospitals must be provided, furnished and supplied. To ensure this, the requisitions of the superintending surgeons will be respected and enforced on the Quarter Masters, Commissaries, Apothecaries and Contractors. Neglect in either of these will be reported to the War Department.

Whenever volunteers or militia are discharged the service of the U. States, the sick will be provided for in the army hospitals, and a competent number of their own surgeons will be retained to attend them.

The Medical staff must be constantly at their posts.

Office of Superintendence of the Recruiting Service, City of Washington, 11th January, 1815.
