

officers, musicians and privates of the several corps of troops now in the service of the U. States, in such manner as to form and complete out of the same the corps authorized by this act, and cause the supernumerary officers, non-commissioned officers, musicians and privates, to be discharged from the service of the U. States, from and after the first day of May next, or as soon as circumstances may justify the measure.

Sec. 6. *And be it further enacted*, That to each commissioned officer, who shall be discharged by virtue of this act, there shall be allowed and paid in addition to the pay and emoluments to which they will be entitled by law at the time of his discharge, three months pay.

Sec. 7. *And be it further enacted*, That the several corps authorized by this act, shall be subject to the rules and articles of war, be recruited in the same manner, and with the same limitations; and that officers, non-commissioned officers, musicians, and privates, shall be entitled to the same provisions for wounds and disabilities, the same provisions for widows and children, and the same benefits and allowances in every respect, not inconsistent with the provisions of this act, as are authorized by the act of 16th March, 1802, entitled "An act fixing the military peace establishment of the U. States," and the act of the 12th April, 1808, entitled "An act to raise, for a limited time, an additional military force," and that the bounty to the recruit, and compensation to the recruiting officer, shall be the same as are allowed by the aforesaid act of 12th April, 1808.

#### NOTICE.

Treasury Department,  
March 10, 1815.

In pursuance of powers, which have been duly vested in the Secretary of the Treasury, under an act of the Congress of the United States, entitled "An act to authorize a loan for a sum not exceeding eighteen millions, four hundred and fifty thousand, eight hundred dollars," approved by the President of the United States, on the 3d of March, current, proposals will be received by the Secretary of the Treasury from this time, until the first day of May next (unless the amount required should be previously subscribed) for a loan to the United States, of the sum of twelve millions of Dollars, or any part thereof, on the following terms, and in the following manner:

1. The proposals must state the amount to be loaned; the rate at which the stock will be received; the instalments in which the party will make the payment, not exceeding, for the whole, ninety days from the date of the subscription, and the banks into which the payment will be made.

2. The payment will be received either in money, or in approved bank notes, or in treasury notes actually issued before the 3d of March, current, under the acts of Congress, passed, respectively, the 30th of June, 1812, the 25th of February, 1813, and the 4th of March, 1814, at their par value, with the interest accrued thereof at the time of payment. The kind of payment intended to be made must be stated in the proposals; and where the terms of subscription are equal, a preference will be given to offers for paying in Treasury Notes, which have become due and remain unpaid, with an allowance of the interest upon such notes, as well face, as before they became due.

3. On failure to pay any instalment at the time stipulated, the next preceding instalment shall be forfeited for the use of the United States.

4. Scrip certificates will be issued by the Cashiers of the Banks into which the payments shall be made, to the corporations or persons, making the payment; the Cashiers will, also, endorse the payment of the five-five instalments; the scrip certificates will be assignable by endorsement and delivery; and will be funded at the Loan Office of the State, in which the bank is situated, where the payments have been made.

5. For the amount loaned, stock will be issued, when the instalments are completed, bearing interest at 6 per cent per annum, payable quarterly yearly. The stock will be reimbursable at the pleasure of the United States at any time after twelve years from the last of December next: and the Sink

ing Fund is charged with the punctual payment of the interest, and the reimbursement of the principal, according to contract.

It is desirable as far as the public interest will permit, to reduce the amount of the treasury note debt, & particularly, the portion of it, which is due & unpaid: therefore, an early subscription is recommended to the holders of Treasury Notes. But, in order to save time and trouble, it may be proper to observe, that the terms of the proposals should bear some relation to the actual fair price of stock, in the market of Philadelphia or New York.

A commission of one fourth per cent, will be allowed to any person collecting subscriptions for the purpose of incorporating them in one proposal to the amount of 25,000 dollars or upwards, provided that such proposals shall be accepted.

#### GENERAL ORDER.

Those officers who have been superintending the recruiting regiments and corps, will muster and inspect such recruits as were actually enlisted before the close of the war. When this shall have been done and descriptive lists made out, according to the forms which have been transmitted for that purpose, they will discharge all such as were enlisted to serve during the war. The recruiting officers will then join their regiments & corps, with those non-commissioned officers, musicians and privates, whose term of service has not expired, except, when the regiment or corps may be on distant service; they will in such case repair to the nearest depot for instruction, of all which, reports and returns will forthwith be made to this office.

Wherever any non-commissioned officer, musician, or private, shall be discharged, separate from his company or detachment, having pay, Sec. du-, he will receive such certificates as will enable any District Paymaster, or other proper officer, to settle the same.

Recruits enlisted for the war, and discharged without joining their regiments or corps, will not receive the retained bounty.
