

any moneys in the treasury not otherwise appropriated, is hereby appropriated for paying the amount of such commission or commissions as may be thus allowed and also for defraying the expenses of printing and issuing the subscription certificates, and certificates of stock, and other expenses incident to the completing of the loan authorized by this act.

Sec. 4. *And be it further enacted*, That so much of the funds constituting the annual appropriation of eight millions of dollars, for the payment of the principal and interest of the public debt of the U. States, as may be wanted for that purpose, after satisfying the sums necessary for the payment of the interest and such part of the principal of the said debt, as the U. States are now pledged and annually to pay or reimburse, is hereby pledged and appropriated for the payment of the interest, and for the reimbursement of the principal of the stock which may be created by virtue of this act. It shall accordingly be the duty of the commissioners of the sinking fund, to cause to be applied and paid out of the said fund, yearly, such sum or sums as may be annually wanted to discharge the interest accruing on the said stock, and to reimburse the principal as the same may become due, & may be discharged in conformity with the terms of the loan. And they are further authorized to apply, from time to time, such sum or sums out of the said fund, as they may think proper, towards redeeming, by purchase, and at a price not above par, the principal of the said stock, or any part thereof. And the faith of the U. States is hereby pledged to establish sufficient revenues, for making good any deficiency that may hereafter take place in the funds hereby appropriated for paying the said interest and principal sums, or any of them, in manner aforesaid.

Sec. 5. *And be it further enacted*, That it shall be lawful for any of the banks in the district of Columbia, to lend any part of the sum authorized to be borrowed by virtue of this act, any thing in any of the charters to the contrary notwithstanding.

Sec. 6. *And be it further enacted*, That it shall be lawful for the secretary of the treasury to accept in payment of any loan obtained in virtue of this act, such treasury notes as have been actually issued before the passing of this act, and which were made by law a charge upon the sinking fund, such treasury notes to be credited for the principal thereof, & the amount of interest actually accrued at the time of the payment.

Sec. 7. *And be it further enacted*, That it shall be lawful for the secretary of the treasury to cause to be paid, the interest upon treasury notes, which have become due and remain unpaid, as well with respect to the time elapsed before they become due as with respect to the time that shall elapse after they become due, and until funds shall be assigned for the payment of the said treasury notes, and notice thereof shall be given by the secretary of the treasury.

#### AN ORDINANCE respecting Nuisances.

Sec. 1. *BE it ordained by the Trustees of the Borough of Vincennes, in council assembled*, That a fine not exceeding five dollars nor less than three dollars be imposed on any person or persons who shall cast any dead carcass, garbage, nauseous liquors or other offensive matter on any street, lane or alley, or on any lot within the limits of this borough, or so near thereto as to annoy the inhabitants in the neighborhood thereof.

Sec. 2. *And be it further ordained*, That if any person shall place any barrels, boxes, crates, any fire wood, or timber of any kind, any brick, stones or earth in the streets, so as to obstruct the free passage thereof, and suffer the same so to remain for 12 hours, every person or persons so offending, shall pay for every such offence the sum of two dollars.

Sec. 3. *And be it further ordained*, That it shall be the duty of the street commissioners to remove or cause to be removed all nuisances from the streets, it shall be their duty to give such person or persons so causing the nuisance, or person or persons owning such lot or lots whereon such nuisance may be found, or facing the streets where such nuisance or obstruction may have been thrown, notice to remove the same; and if

the person so notified, shall neglect or refuse to remove or cause to be removed such nuisance or obstruction in 24 hours after such notice, then the street commissioners shall direct the town constable to have the same removed at the expense of the person or persons so neglecting or refusing, which expense and costs of suit, shall be recoverable before any justice of the peace in said borough; and nevertheless, the person or persons so offending, shall be subject to be fined, as prescribed in the first section of this ordinance.

Sec. 4. *And be it further ordained*, That one half of all fines, (unless expressly otherwise appropriated) shall go to the informer, or person prosecuting for the same to conviction and recovery, and the other half to the use of the borough. And it shall in all cases, be the duty of any officer, or other person, prosecuting or informing against any person for offences committed against any of the ordinances of this borough, to do the same within ten days after the commission of such offence or offences.

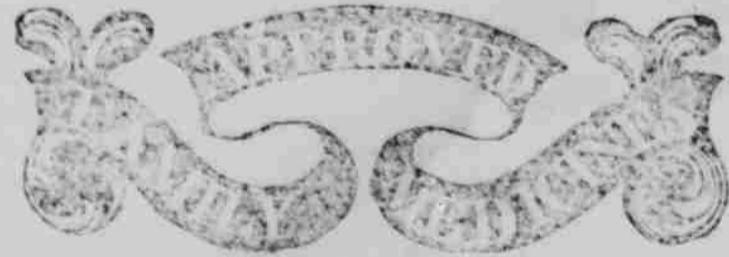
Sec. 5. *And be it further ordained*, That it shall be the duty of the street commissioners, to notify the town constable to take in charge any person or persons who may keep, or does keep a disorderly house; and where it is proven that he, she, or they, have suffered and encouraged drunkenness, revelling, rioting or gaming, so as to annoy the neighborhood thereof, he, she or they, so offending, shall on conviction thereof, pay a fine of five dollars for each and every such offence, to be recoverable before any justice of the peace in said borough.

Sec. 6. *And be it further ordained*, That if any person or persons shall make a bon fire in any of the streets of this borough, without having first obtained the permission of the chairman of this board for so doing, such person or persons so offending, shall forfeit and pay for every such offence, the sum of five dollars.

Sec. 7. *And be it further ordained*, That in all cases where fines are assessed, and the person or persons fined shall neglect or refuse to pay such forfeitures, or goods and chattels whereof to levy the same by distress, cannot be found, such person or persons shall be committed to the charge of the street commissioners, to be kept at hard labour for the time necessary to pay such fines, of which he or they may be convicted.

Enacted into an ordinance this 15th day of May, 1815.
