THOSE soldiers belonging to the late army of the United States entitled to pensions are informed that it is only necessary to forward their discharge & certificates of disability to the War Department stating in what particular state territory or district they reside and wish to receive their allowances when certificates of pension will be issued by the Secretary of War, and forward to them free of all charge whatever; and also that the services of an agent are not at all required in procuring for them their pensions awarded by the government to their gallantry & their wounds.

300 Dollars Reward.

RANAWAY from the subscriber at Cumberland Furnace Davidson county Tennessee, some time in May 1815, a negro man **CARRY** but has since changed his name to **BUCK**, and will change it as often as he changes his situation. He is likely stout well made young fellow, about 26 or 27 years old, of a copper color; his height not known, but supposed to be 5 feet 9 or 10 inches high, arge made to his height his foot broader across the toes than common; intelligent but not remarkable for honesty or industry. He descended Cumberland river in a keel boat to the mouth, there shipped himself on board capt. Blackman's barge as a hand to Cincinnati, but at Louisville unshipped himself and travelled by land in company with a man that lived at that time 16 miles from Brownsville, P. as far as Chillicothe; there detained some time. It is probable he has since pressed to Pittsburgh, or some part of the State of Pennsylvania or the State of Ohio or perhaps the adjacent territories. He had a forged pass in the name of some gentleman in the neighborhood of Chillicothe, with permission to hire himself and said he was returning home. I will give the above reward for him if lodged in jail and information given to me so that I get him, and reasonable expenses paid if brought home.

Fifty Dollars Reward.

Ranaway from me at the same place, on the 20th June 1816, a young negro fellow named **BOB**, about 22 or 23 years old, of middle size, and of a copper color. As well as I recollect his middle toes on both his feet contracted by corns; had on when he run away a home manufactured mixed cloth coat, with white metal basket buttons but

will no doubt change it the first opportunity; the balance of his clothing not recollected. If caught neither will acknowledge to whom they belong but will try to make their escape if not securely ironed & taken care of. I purchased Bob of maj. David Smith on the elk fork of Red river—he formerly belonged to Mr. Frederick Hise, of Russellville Ky. may return to that place; but it is presumed he will attempt to go to Pittsburgh, either up the river Ohio in a boat as a hand or by land as he says he has relations in Pittsburgh. I will give the above reward to secure him in jail and give me information so that I get him and reasonable charges if brought home.

A PROCLAMATION.

By the President of the United States.

WHEREAS by the act entitled "An act granting bounties in land and extra pay to certain Canadian Volunteers," passed the 5th of March 1816, it was enacted that the locations of the land warrants of the said volunteers should "be subject to such regulations as to priority of choice, & the manner of location, as the President of the U. States shall direct:"

Wherefore, I James Madison, President of the U. States in conformity with the provisions of the act before recited, do hereby make known that the land warrants of the said Canadian Volunteers may be located agreeably to the said act, at the Land Office at Vincennes, or Jeffersonville in the Indiana Territory, on the first Monday in June next with the Registers of the Land Offices; that the warrantees may, in person or by their attorneys, or other legal representatives, in the presence of the Register and Receiver of the land districts draw lots for the priority of location, and that should any of the warrants not appear for location on that day they may be located afterwards, according to their priority of presentation: the locations in the district of Vincennes to be made at Vincennes, & the locations in the district of Jeffersonville to be made at Jeffersonville.

By the President of the United States.

WHEREAS by the act entitled "An act providing for the sale of certain lands in the Indiana Territory & for other purposes," passed the 30th of April 1810, it was enacted that a part of the said lands should be offered for sale to the highest bidder under the direction of the register of the Land Office and of the Receiver of public monies of the places respectively where the Land Offices are kept, on such day or days as shall by proclamation of the President of the U. States be designated for that purpose, in tracts of the same size, and on the same terms and conditions, as have been or may be provided for lands in the same districts:

Wherefore I James Madison, President of the U. States in conformity with the provisions of the act before recited do hereby

by declare & make known, that sales shall be held on the first Monday in September next and five succeeding days in Jeffersonville in the Indiana Territory, for the disposal of such part of the lands aforesaid as lie in the district of Jeffersonville, which have not been reserved by Law for Schools or for other purposes, and the plats of survey of which shall have been transmitted, prior to that day, by the surveyor general to the Register of the Land Office at Jeffersonville and that sales shall be held at Vincennes in the In. Ty. on the second Monday in September next & 3 succeeding weeks for the disposal of such part of the lands aforesaid as lie in the district of Vincennes, which have not been reserved by law for schools or for other purposes, and the plats of survey for which shall have been transmitted, prior to that day, by the surveyor general to the Register of the Land Office at Vincennes.

Land-Office at Vincennes,
May 22, 1816.

IN conformity with an act of Congress, entitled "An act for the relief of certain claimants to land in the District of Vincennes," passed on the sixteenth day of April, one thousand eight hundred and sixteen, it is hereby made known, that the several persons whose claims were confirmed by the act of Congress, entitled "An act confirming certain claims to land in the District of Vincennes, and for other purposes," passed March third, one thousand eight hundred and seven; and the act, entitled "An act confirming certain claims to land in the District of Vincennes," passed February thirtieth, one thousand eight hundred and thirteen—"Which having been located cannot be surveyed agreeably to law, or which having been located, have been removed by the survey of prior locations, from the spot inteded to be occupied," may on the second Monday of July next, enter their locations with the Register of the Land Office, or on any succeeding day.

Land-Office at Vincennes,
May 22, 1816.

WHEREAS by an act of Congress, entitled "An act relating to settlers on the lands of the United States," passed on the 25th day of March, 1816, it is provided, "That any person or persons who, before the first day of February, one thousand eight hundred and sixteen, had taken possession of, occupied, or made a settlement on any land ceded or secured to the United States, &c. and who at the time of passing this act, does, or do actually inhabit or reside on such lands, may, at any time prior to the first of September next, apply to the proper register, &c. requesting the permission to continue thereon, &c."—NOW BE IT KNOWN, that in conformity with the provisions of the said act, every person in the district of Vincennes, circumstanced as above, may file his application in the office of the register at Vincennes, at any time previous to the first of September next, from which day inclusive, no more applications can be received.
