The Spanish Patriots it is said contemplate an attack very soon on Pensacola, and it is expected that place will become the scene of military operation on a large scale between them and the Royalists. The U. States will have at Fort Montgomery, not far distant, a respectable force, to protect our neutrality against the aggressions of either party.

Since the removal of our troops from Camp Crawford near Appalachicola Bay, the Indians in that quarter have manifested an unfriendly disposition, by burning the houses erected there for the accommodation of the troops &c. and a large number of the savages are said to be embodied, as if they contemplated further mischief.

LONDON Jan. 1

It is understood that the differences between Russia and the U. States, relative to the arrest of the Russian consul, have been amicably adjusted. Mr. Alexander Everett, who lately arrived in this country from America, on his way to Russia, with despatches, learnt, from advices received by the American ambassador here, that the emperor had recalled M. Daschkoff and it was added, with some marks of displeasure, on account of the conduct which the latter had adopted on occasion of this dispute. In consequence, Mr. Everett did not proceed to St. Petersburg, but departed for Brussels, there to replace Mr. Eustis.

Detected Conspiracy at Bordeaux.

Letters from Bordeaux of the 21st inst. were received in town on Saturday. One is from a gentleman there, addressed to the firm with which he is connected in London. It communicates intelligence, that a considerable number of persons were apprehended at Bordeaux, during the night of the 20th, by order of government, on a charge of being concerned in a conspiracy to restore the Bonaparte dynasty to the French throne. The intention of the conspirators it is said was to declare Maria Louisa, Regent of France during the minority of her son—This attempt has excited the greater surprise considering the quarter where it has been made, as Bordeaux has taken the lead in its loyalty, among the cities of France. There are other places in the South of France in which fidelity to the government is said to be questionable.

Extract of a letter from Norfolk to a gentleman in this city, dated the 21st instant.

"Two privateers, under the Buenos Ayres flag, have arrived at this port; one is a brig, called the Independence of the South, and the other a schooner called the Altavada, alias the Romp. On coming up they saluted the fort, which was returned. The brig mounts sixteen guns, of heavy calibre, with a crew of 150 men all Americans or British subjects as nothing but English is spoken on board; there are not three Spaniards amongst the whole crew.

"The exact amount of specie which they have on board is not known; some say 90,000 dollars, and others 290,000 dollars but it has been ascertained they have deposited \$ 60,000 in the Bank. These vessels were both fitted out at Baltimore."

BOLIVAR DEFEATED.

Extract of a letter from the commandant of Marines at Santa Martha, to a gentleman in this city, dated 9th February.

"Bolivar has been entirely defeated on the River Unare, between Barcelona and Cape Codera. He has disembarked upwards of 900 men, and has lost more than 500. He was wounded, and escaped by flight, with Arismendi, pursued by the cavalry. The royal troops consisted of 550 men, 700 muskets, a peice of cannon, and 20,000 cartridges, with balls, drums, standards, the writing desk of Bolivar, in which was his picture and his father, fell into our hands."

FOREIGN.

The London papers assert that Mr. Pinkney during his stay at Rome, negotiated a treaty between the U. States and Italy.

The coast of Spain continues to be infested by South American privateers.

The Spanish government is about sending commissioners to S America, to offer the Patriots pardon, on condition of their returning to their allegiance to Ferdinand!!! During the war of our revolution, a similar proposition was made by the British government to us. It is hoped the Patriots will treat the degrading proposal in the same manner as the North American Congress treated the insidious overtures of Great Britain.

The British government have complimented the American consul in London, as almost the only one who takes care of the suffering seamen of his country in England.

Emigrations from Switzerland to America have again commenced.

On the 8th of January so thick a fog prevailed in London, that all the shops were lighted as in the night.

VIENNA, Dec. 24.

Mr. Pinkney, minister from the U. States, in passing here for St. Petersburg, upon his obstinate refusal to submit to the revenue laws, was stopped for some hours with his suite, at the principal custom house.—Upon his complaints, they made him the satisfaction the circumstances required.

Letters from Warsaw state, that the Emperor of Russia has issued a decree establishing a military conscription for the Kingdom of Poland, according to which every person, without distinction of rank, origin, or religion, is to perform military service during ten years, from the age of 20 to 30.
