In a popular government like our own, it is the undoubted privilege of the people to scrutinize and examine into the character and conduct of its Public Functionaries. Is it not then a matter of surprise to see with what tameness the people (particularly those called into service during the late war) submit to the impositions, which have been practised upon them from the pay department? We would beg leave to ask Mr. Whitlock a few plain questions on this subject? Pray sir, were not those soldiers whose claims for services you were authorized to pay, entitled to receive specie, or at least such banking paper as stood at par? If so, why pay them in the money of unchartered banks, or such as passed only at a considerable discount? Which we have no hesitation in saying is a fact. If therefore, our premises are correct, the conclusion necessarily follows, that a base speculation, and fraud, must attach somewhere. This charge however we do not wish to locate, neither do we know that it is at this time in our power to do so. But we must say, that an explanation, from some source or other, is absolutely indispensable, & until this is obtained suspicions may rest upon the wrong shoulders.

MESSRS. COX & NELSON,

In answer to the questions asked me by a citizen, under the head of soldiers pay in your paper, I will observe that so far as I have paid the militia claims for services rendered in this state, it has been done with the precise kind of medium that has been placed in my hands, for that purpose by the government, and the last payment that I did make to the militia of this state, was with funds that I drew on the authority of the secretary of the Treasury of the United States, from the Receiver of the Public monies at this place, which funds was in bank paper on the following banks—& whether it is, or was at par, or not, I do not conceive it would be proper for me to say, as it came direct from the Treasury of the United States.
