We have received a Gibraltar paper of the 10th of May, in which it is asserted, that the Tunisian Bashaw has been notified by Capt. Forrest, of the British Frigate Astrea, in the name of the Prince Regent, that he may go to war with whomsoever he may think proper, provided he comply with the article relative to the abolition of slavery.—*N. Y. Gaz.*

NEW-YORK, JULY 8.

The brig Sally has arrived at Boston, in 44 days from Liverpool, bringing London papers of the 13th, and Liverpool papers and letters to the 17th of May. Left about 40 sail of American vessels.

The London Traveller of the 13th of May states, on the authority of private advices from Hamburg, that serious differences had arisen between the courts of Stockholm and Copenhagen. The Emperor of Austria is also stated to have taken possession of Rome.

It was said, that the expedition fitting out at Portsmouth, was intended to aid the Spanish government in subduing her revolted provinces in South America.

A war between Spain and Portugal, it was rumored, would probably take place.

Gen. Jencks, of Windsor, in Connecticut, raised last year from 54 acres 417 bushels of rye, 285 of wheat, 2400 lb. of tobacco, 150 bushels of turnips, 1600 of potatoes, and 60 tons of hay. And this in a year of which we complain. *Essex Register.*

Jutphaas, (Netherlands) April 24.

We have seen pass by this place, at different times, in the course of this year, some thousands of individuals of both sexes chiefly from Switzerland, destined for Utrecht in order to proceed to America.—This emigration seems to increase. Yesterday passed six vessels, on board of which were 1200 Swiss families, from the Canton to Basle. To day 600 have passed, who are to be followed by a still greater number.

#### IMPORTANT REPORT.

Captain Campbell, arrived this morning from Savannah in 30 hours, informing us, that a report prevailed there when he sailed, that the patriot forces took possession of Amelia Island on Sunday last. We think there is a great probability in this rumor.—*C. City Gaz.*

#### FLORIDA.

Extract of a letter to the Editors, dated Savannah, June 9.

"The subject most talked of here is, the probability of a speedy cession of the Floridas to the United States. That it will take place, every one believes—and that belief is strengthened by the fact, that the Spanish authorities in those provinces speak of such an event as certainly about to happen; and the residents who hold land, anticipating its increased value when annexed to our government, demand for it a very high price." *Bost. #### Liberation of Bonaparte.

Capt. Brinard, of the ship Fox, arrived at New York from Matanzas, informs that while at that place, capt. Baker arrived there in 3 days from Nassau. N. P. stated that a vessel had arrived at

Nassau in a short passage from England with intelligence that Bonaparte had been set at liberty by an order from the British government, and that he had sailed from the island of St. Helena for Malta. *[Fudge.]*

#### Amelia Island.

By the arrival yesterday, of the ship White Oak, from St. Mary's, we learn that the people of East Florida, were in a constant state of alarm. Intelligence had been received that it was the intention of the patriotic privateers to take possession of the Island of Amelia. A number of families had fled to St. Mary's for safety. It was reported that Sir Gregor McGregor, who was at Charleston recruiting men, was to command the expedition. In addition to the above, the Charleston papers, received by yesterday's mail, contains the following:
