

FROM ALGERS.

Boston July 28

By the arrival at this port yesterday of the brig *Aurelia*, direct from Algiers in 56 days, we learn that on the 9th of May a frigate arrived at Algiers from Constantinople, a present from the Grand Seignor to the Bashaw. A few days previous, a large polacre of about 400 tons arrived from the same place, loaded with munitions of war of every description.

The Grand Signor has paid many and high compliments to that Bashaw for the firmness and energetic conduct he has display'd during the late unhappy state of his affairs, & has presented him with a captain's dress on this occasion, which is one of the greatest possible honors. On the 11th, 13th and 14th of May, the greatest rejoicings were evinced in consequence of these honors being paid his Highness by the Grand Signor. Salutes of shotted cannon were made on these days three times a day, from more than 600 pieces of cannon.

On the 28th May, an Algerine brig and schooner sailed on a cruise; against what nation is not yet known; their navy may now consist of one frigate, two sloops of war, lately arrived from Constantinople; (repairing) one sloop of war on the stock building three 18 gunbrigs, and one 18 gun schr. at sea.

On the 29th May, a Tuscan Ambassador arrived at Algiers for the purpose of negotiating a peace for that Dudedom. The American Consul left Algiers the 10th of May on board the frigate United States on a visit to Tripoli and Tunis.

The last Boston Intelligencer relates the following in speaking of the President's tour:—

At Enfield, Vermont, he visited the "Habitation of the shaken community" to use their own phraseology, or in more familiar language the shaking Quakers. He was received with the simplicity that distinguishes that sect. The elder came forth from the principal house in the settlement, and addressed the President, "I Joseph Goodrich, welcome James Monroe to our habitation." The President examined the institution and their manufactures; was also welcomed by the women and, having remained about an hour, he retired very much pleased with his visit.

A daughter of Stephen Burroughs, of counterfeiting memory, lately took the veil at Three Rivers. It is not to be wondered that the daughter of Burroughs should seek to hide the shame caused by a father's vices in the cloisters of a nunnery.

Accounts from Halifax represent that the crops in Nova-Scotia promise to be more abundant than in any past year.

The steam-boat *Vista*, which plied from Philadelphia to Wilmington, has been burnt to the water's edge at the latter place. She took fire by accident.

To the Editor of the Western Spy.
Claims for Property lost, &c.
During the late War.

MILITARY AND GENERAL AGENCY,
Washington City, 10th March, 1817.

SIR—For the information of your readers, should you think proper to publish it, I take the liberty to apprise you that the act passed on the 9th day of April, 1816 entitled "an act to authorize the payment for property lost, captured or destroyed while in the military service of the United States and for other purposes," has been amended by an act of the late Congress, so as that he 1st Section limits the provisions of the 6th section of the former act, to buildings occupied by order, as a place of deposit for military and naval stores, or as barracks for the military forces. Claims under this, and the 9th section aforesaid, to be investigated by the Commissioner and reported to Congress.

2d Section provides for the appointment of special Commissioners as formerly who are requested to take an oath of office. Commissioners authorised to appoint an agent in behalf of the United States, to join with the special Commissioners, when he may deem it expedient.

3d Sec. provides for payment of anyorse, mule, ox, waggon, cart, sleigh or rorrsness lost in service, except when the rorw was to have been incurred by the owner.

4th Section extends the provisions of this and the former act, to cases of property lost, captured or destroyed in the wars with the Indian tribes subsequent to the 18th February, and prior to the first day of September, 1815—and the 5th and last section, provides that all claims of 200 dollars or upwards, shall be reviewed by the secretary of War, and may be confirmed or rejected by him.
