HARMONY, INDIANA.

The land held by them in Pennsylvania, from the increase of their numbers, being too small for them they purchased a large and beautiful tract on the Wabash, in the new state of Indiana, and removed to it just about three years ago. It was then in a state of nature. They already have many good houses, large work shops and extensive barns—one of them 100 feet by 45 another 200 feet long and 45 wide; a steam mill driving two pair of stones; a very large brick house in the shape of an L, for Mr. Rapp, with an excellent and highly ornamented garden, inferior to few in the United States; they have 1500 Merino sheep, whose wool they manufacture into excellent broad cloths with a large stock of cattle, hogs, &c. and carry on almost every trade & manufacture, as well for their own use as to make things for sale—among them are tin-workers, shoemakers, saddlers, joiners, carpenters, hatters, stocking and other weavers, tanners, blacksmiths, &c. &c. They have many acres planted with the vine 200 in wheat, 40 in rey, 30 in barley 30 in oats, 50 with meadow grass, and 500 enclosed in pasture fields. All these things have been done in three years. This society is numerous, amounting, we believe to nearly 300 families who have all things in common; are among the most industrious and economical people in the world, and very harmless and inoffensive. The first body of them emigrating from Germany, settled in Pennsylvania in 1803—4. They then consisted of 160 families and were soon after joined by 90 families more. Niles

American Pedestrian.

Mr. Joseph Bell, House Carpenter started from Gibson's Hotel, Wall-street New-York, at three o'clock in the morning of Wednesday the 3d of September, and reached Philadelphia at six o'clock in the evening of the same day: after delaying about three quarters of an hour on the road rendering assistance to a carriage that broke down—he was to walk from New-York to Philadelphia & back again in 48 hours, a distance of 192 miles and to rest as long as he pleased during the journey; But of which provision he did not avail himself, having taken but 3 hours rest walking about the city the rest of the time until he started to return, which was at half past two o'clock on Thursday evening the 4th of Sept—He is accompanied on his journey by a man and horse—The bet is held by Mr. Sauncey merchant, and Mr. Price manager of the Theatre, both of New-York, for \$500.

BALTIMORE, Oct. 4.

We learn that Powder Mills on Jones Falls about 7 miles from this city, belonging to the Messrs. Leverings and others, were blown up this morning about 1 o'clock. The shocks caused by the explosions three in succession, were distinctly perceived in this city. It is stated that three houses were entirely destroyed, and upwards of 200 casks of powder; the roof of another house, used as a magazine, and containing a large quantity of powder, was blown off but providentially the fire did not reach the powder.

We regret to add, that after this dreadful explosion three men were found dead, one other whose body has been found is supposed to have been destroyed and four men were severely wounded.

Explosion.

About one o'clock on Friday morning last, the incorporating building attached to the Orange powderworks situated about three miles from this village, owned by Asa Taylor and Co. took fire from a fraction and was blown up. No other building was injured. The loss must have been considerable, but we have not been able to ascertain the amount.

Baltimore, August 14.

It is stated by a respectable gentleman, that a small boy was found yesterday six miles below Foat M'-Henry floating on a piece of timber, having been carried down the flood on Saturday last. He was alive, and though very hungry, not otherwise injured.
