### Extract of a letter to the Printers of the Reporter.

New Orleans, Oct. 4, 1817.

"I am sorry to inform you, that the Yellow Fever has made great ravages in this city from the beginning of August to this time it does not seem to abate in the least; even the creoles of the place, have not escaped its baneful influence; they die now as fast as the Americans did when it first made its appearance. Very few of the latter dying at present."

### Extract of a letter to the Printers of the Reporter.

New Orleans, Oct. 12, 1817.

"Two thirds of the inhabitants have left town, yet as many die here as ever, so that the fever is more fatal now than heretofore."

"The Governor, by proclamation convened the general Assembly at Washington, on Monday last instead of this place. After electing two Senators to Congress, they adjourned to meet in this place on the 2d Monday in December next. Judge Leake and Thomas H. Williams esq. were chosen, both of the gentlemen well calculated to fill such a station.—They are politicians of the old school, and are honest and independent men."

"No permanent appointment of Judges has yet been made. Mr. Ellis, lately from Virginia, & Mr. J. Taylor have been appointed temporarily."

"I suppose you scarcely ever saw such a spectacle as the city now exhibits; empty streets—closed doors—and a mute population, who are mostly confined to their rooms. How long these things will continue we cannot tell; meanwhile the children of Adam are constantly passing from amongst us."

### Extract of a letter to the Printers of the Reporter.

Franklin, Ten. Oct. 16, 1817.

Gentlemen.—On the first day of this month the Bank in this place commenced its operation, under the name of the "FRANKLIN TENNESSEE BANK;" it was chartered by an act of the legislature in October 1815. R. P. CURRIE, President, & WM. EASTON, Cashier. It commenced entirely on a specie capital, and is supported by wealthy and respectable stockholders."

Abraham G. Claypool of Philadelphia is appointed Cashier of the U. S. Branch Bank at Chillicothe, and the following gentlemen directors:—Edward Tiffin, Duncan McArthur, Samuel Finley, Joan P. R. Bureau William K. Bond Joan M. Laudburgh, William Creighton jr, John Carlisle, Edward King, John McCoy Alexander McLaughlin, George Renick William M. Farland. The institution is expected to commence business about the first of December.

### RUSSIAN EMPIRE.

So vast is the extent of this empire, that when it is noon-day in its western parts, on its eastern confines it is nearly midnight. Exclusive of all its acquisitions from the Turks and from Poland it forms a square, every side of which mea-

sures more than two thousand English miles. Some geographers make each side of the square from thirty to forty miles more. Be that as it may it is certain that it is of twelve times the dimension of any other kingdom in Europe, and far exceeds the territories of the Roman empire, even in the zenith of its glory.

### Latest from England.

The Liverpool Mercury of August 15th states, since the port opened for grain in November last, there had arrived in that place 80,000 quarters of foreign wheat not Irish, and 423,000 barrels of flour.

**Spanish Colonies.** A Morning Paper states, on what it calls "authority of the first respectability, that a treaty has been carried into effect under the powerful mediation of Russia, binding Great Britain and the other maritime Powers to join in concert to effect the submission and pacification of the Spanish Colonies; and that a new political regime, quite different from the former is to be established, particularly as far as regards foreign trade, to which full liberty is to be given, under certain modifications."

Of the gross impolicy of such interference we have already more than once expressed our opinion; and as the fact of a treaty having been actually entered into for the purpose, we need go no further than to the sequel of this report itself, refutation, where it is very consistently affirmed that "it is not known how far the Spanish Government will adopt all the clauses." "Adopt" the clauses of a Treaty which is previously stated to "have been carried into effect!" That negotiations for such a treaty are on foot we think probable enough; but we feel quite assured that as yet nothing of the kind has been completed. The same report adds that another treaty is on the tapis, under exactly the same meditation, by which Spain is to continue the slave trade till the year 1820, and to receive from England a large indemnity for the losses she has experienced by the capture of vessels employed in this trade.

### FROM THE SOUTH.

CHARLESTON, OCT. 4.

We have been favored With the following copy of a letter dated

St. Mary's, 27th Sept. 1817.

"On Monday last the Spanish forces embarked from Amelia Island, and those on the Main took up their line of march for St. Augustine. The militia having previously returned to their homes completely disgusted with the service of the Royalists & have since made their peace with the liberating army."

"Com. Aury has been elected captain general Col. Irwin commandant of the land forces, R. Hubbard, Esq. governor of the two Floridas, Henry Younge collector, and W. M. Ogieby marshal and every thing going on well the prizes now in port are two Spanish ships and two brigs containing upwards of three thousand boxes sugars a quantity of coffee indigo, cochineal & specie and a large ship is now coming in laden with sugar and hides. The whole property now afloat in these waters is said to be worth half a million of dollars. Cash has only begun to circulate since the arrival of Com. Aury, he having loaned sufficient money for paying the troops, and for other emergencies. Salt provisions and all kinds of bread stuffs begin to be in demand."

A conjecture is in circulation, that a negotiation is on foot for exchanging our claim to the territory west of Nacogdoches, for Florida. Nacogdoches is about seventy miles west of Nachitoches the most westerly military post of the United States.—Richmond Enquirer.

### Military Bounty Land.

General Land Office,  
25th Sept. 1817.

NOTICE.—The lands in the Illinois Territory, appropriated for bounties for the military services having been surveyed and the surveys received at this office, the distribution of the said lands, by lot agreeably to law, will commence at this office on the first Monday in October next.

The surveys of military bounty lands in Missouri Territory are expected and few months, when a similar distribution will take place, of which timely notice will be given in the newspapers. Those who wish to locate their warrants in Missouri Territory may send them after the publication of that notice.

Every soldier of the late army who has received from the Department of War a land warrant, or a notification that it is deposited in this office, may obtain a pa-

tent by sending to this office the warrant or notification, first writing on it, "To be located in the Illinois Territory on the patent to be sent to the Post Office at —."

The patents of soldiers who have notified, or shall hereafter notify the General Land office not to deliver them to their agents heretofore appointed, will be retained, subject to their further order.

Members of Congress who have deposited (in this office) soldiers warrants or notifications, may obtain patents for them by sending receipts which were given by the office, and instructions relative to locating the warrants.

Printers who publish the laws of the United States will give the above so many insertions as will amount to ten dollars, send a copy of the papers to this office, and a bill, receipted; the money will be sent by mail.
