FRIDAY, Dec. 19.

On motion of Mr. Beggs, Resolved, that a committee be appointed to take into consideration the propriety of taking the sense of the people of this state on that part of the constitution, which fixes the seat of government at Corydon until the year 1825 and Messrs. Beggs, Dunn, Milroy, Carr, Slaughter, Ferguson, Stevens and Sullivan were appointed that Committee.

Mr. Stevens from the joint committee of revision, reported a bill declaring what laws shall be in force—also, a bill giving certain remedies in equity;—and also a bill rendering authentic records, evidence of proceedings in other states; which were read, and ordered to be read a second time.

Mr. Ferguson, from the committee on the subject of the Ohio canal company reported a bill; which was read, and ordered to be read a second time on Monday next.

Mr. Ferguson, from the committee appointed on that subject, reported a bill to authorize William Wright to build a toll bridge across Silver Creek, which was read, and ordered to be read a second time on Monday next.

Mr. Carr presented the petition of Richard Austin, on the subject of a ferry across the mouth of Silver Creek, which was read and ordered to lie on the table.

Saturday Dec. 13.

Mr. Baird, from the committee on that part of the governor's message, which relates to a state library, reported it as their opinion, that this subject ought to be postponed.

Mr. Montgomery introduced a bill respecting public seminaries, and for other purposes which was read, and ordered to be read a second time on Tuesday next.

The engrossed bill, relative to applications for new counties was read the third time and passed.

Mr. Penington presented, the petition of the Trustees of the school section in township No 3 south, of range No 5 east, which was read, and referred.

The bill, organizing Reply county was read a third time and passed.

The bill for granting writs of ne exeat, was read the third time and passed.

The bill directing mode of changing the venue, was so amended, as to repeal all laws on that subject was read the third time and passed.

Mr. Penington presented the petition of William Wright praying his marriage with Mary Inward, may be legalized; which was read, and ordered to lie on the table.

Tuesday, Dec. 16.

Mr. Paul, from the joint committee of revision reported a bill concerning the duties of sheriffs and coroners;—a bill, to license and regulate Taverns;—a bill, respecting apprentices; which were read and ordered to a second reading.

Wednesday Dec. 17.

Mr. Ferris from the joint committee of enrolled bills, reported that the committee had examined the joint resolution of the senate and house of representatives,—also an act respecting non-resident attorneys and counsellors at law, and find them truly enrolled.

Thursday Dec. 18.

Mr. Paul, from the joint committee of revision reported a bill, to prevent trespassing by cutting of timber; which was read, and ordered to be read a second time on Saturday next.

The bill to regulate marriages, was read the third time and passed.

The bill, for a new county out of the east end of Pike county, was read the third time, and passed.

Friday Dec. 19.

Mr. Ferris from the committee of enrolled bills reported that the said committee had examined an act repealing all laws, and parts of laws, directing the mode of changing the venue,—also a bill, for a new county out of the eastern end of Pike county, and had found them truly enrolled.

Mr. Paul from the committee of revision reported a bill for the appointment of constables;—a bill authorizing aliens and foreigners to purchase and hold real estates within this state—and a bill regulating weights and measures, and a bill respecting grist mills and millers; which were read, and ordered to be read a second time on Friday next.

Mr. Paul from the joint committee of revision, reported a bill for the relief of the poor, which was read, and ordered to be read a second time on Wednesday next.

House of Representatives.

SATURDAY, December 20.

Mr. Dunn introduced a bill relinquishing the shares reserved by the state, in the Farmers' and Mechanics' Bank of Indiana; which was read and ordered to a second reading.

Monday, Dec. 22.

Mr. Stevens from the committee of revision, reported a bill for the revival of certain suits and actions; which was read and ordered to a second reading.

Mr. Sullivan presented the petition of John M'Nought and others praying for a new county out of the counties of Orange, Davis and Sullivan;—Also the petition of Isaac Hunter, praying for two new counties out of the county of Sullivan; which was read and referred.

Mr. Hunt, from the joint committee of revision, reported a bill for the support of illegitimate children; which was read and ordered to a second reading on to-morrow.

Mr. Sullivan introduced a bill authorizing the issuing of writs of certiorari in certain cases, which was read and on motion of Mr. Stevens, the further consideration of said bill was indefinitely postponed.

Tuesday, Dec. 23.

Mr. Sullivan, from the committee to whom was referred the petition of sundry inhabitants of Sullivan county, reported a bill for a new county out of Sullivan, which was read, and ordered to second reading.

Mr. Hunt, from the joint committee of revision, reported a bill to perpetuate testimony; which was read and ordered to be read a second time on Wednesday next.

Mr. Ferguson introduced a bill providing for three per cent. of the nett proceeds of certain lands within this state; which was read and ordered to a second reading.

On motion of Mr. Stevens, Ordered that a committee be appointed to obtain by loan or purchase a complete set of the statutes of the late Territorial Government, and of the state of Indiana, for the use of the house for the present session; and Mr. Stevens was appointed that committee.

Mr. Conner introduced a bill to prevent non-residents from bringing stock into this state and turning them into the range which was read, and ordered to be read a second time to-morrow.

Mr. Sullivan introduced a joint resolution to prepare the acts of the present General Assembly to be printed in the most speedy manner; which was read & ordered to be read a second time on Wednesday next.

Mr. Stevens who was appointed to procure the statutes for the use of the house reported, that he had performed that duty.

Mr. Slaughter presented the memorial of the Medical Society of the 2d Medical District; which was read, and ordered to lie on the table.

The bill, authorizing the appointment of a pilot at the falls of the Ohio, was read the third time and passed.

The bill defining and regulating privileges in certain cases was read the third time and passed.

The bill, organizing the Supreme courts and regulating the practice therein; was read the third time and passed.

The bill from the senate, authorizing writs of ne-exeat and regulating the proceedings thereon, was on motion of Mr. Stephens, read the third time & passed.

Mr. Sullivan introduced a bill, effectually to prevent duelling, which was read, and Mr. Beggs moved that the further consideration thereof be indefinitely postponed; and on the question for postponement, it was decided in the negative.

On motion of Mr. Stevens, Ordered, That a committee be appointed to enquire into the expediency of memorializing Congress, on the subject of obtaining, by purchase or otherwise from the Indians, permission for the state of Indiana, to lay out and open a public highway from Brookville to Fort Harrison; and thereupon Messrs. Ste-

vens, Sullivan, Ferguson, Dunn and Daniel, were appointed that committee.

The bill for the support of illegitimate children, was read the third time and passed.

The bill, for a new county out of Warrick and Posey;—the bill for a new county out of Warrick, Gibson and Posey, and to remove the seat of justice of Warrick county; and a bill to attach a part of Harrison county to that of Posey, and to remove the seat of justice of Perry county, were read the third time, and passed.

The bill, for the assignment of dowers, was read a third time and passed.

The bill regulating the fees of several officers, and persons therein named, was read the third time and passed.

The bill making an appropriation for Wolf scalps, was so amended as to appropriate \$1000; and on the question, will the house concur in said amendment, it was decided in the affirmative.

The bill from the house of representatives concerning joint rights and obligations, was read the third time & passed.

The bill, prescribing the mode of proceeding against absconding debtors, was read the third time and passed.

The bill, from the house of representatives, establishing Ferries was read a third time as amended in committee of the whole, and passed.

The president laid before the senate, the petition of William Kelso, which was read and referred.

WEDNESDAY, Dec. 24.

Mr. Polke introduced a bill restraining Hawkers, Pedlars, and petty chapmen from selling without License in this state, which was read and ordered to a second reading.

The bill to provide for the partition of real estates was read the third time and passed.

The bill from the house of representatives, to improve breed of horses was read as amended, and passed.

The bill authorizing aliens & foreigners to hold real estate within this state, read and passed.
