

Extract of a letter from the "MAN IN THE MOON," to a gentleman of this place.

"I have been too often under a cloud since my last, to say much; and besides, my disk has been so unusually dark, that when relieved of all obstruction, my eyes could only bear to take an occasional glimpse of your Legislature, without becoming painful.

"I can however inform you, that your unparalleled governor Jennings is saved for the present, by a majority of two votes in the lower house: and one of them was Mr. Joseph Warner!! The committee appointed to enquire into that governor's conduct, brought in a sort of half-going, half-limping, half-nothing report, I suppose to ascertain the pulse of the members generally, whereupon a motion was made, stating that it was 'inexpedient' to prosecute the enquiry; and behold! it was adopted, 15 to 13. Thus the matter sleeps in that house; but can it possibly sleep in the mind of your citizens? If so, your constitution and laws are as blank paper, or worse, for they restrain your citizens, while your governor may, it appears, bend them with impunity to suit himself. The constitution and laws which regulate and govern our inhabitants of the Moon are not mutable in that way; here truth is made manifest, and the public good our governor's rule of conduct. Let me, my dear sir, entreat you to influence your fellow citizens to adopt our mode, and to render it obligatory upon the next governor they elect, which if I do not err, will be in August next.

"I sincerely congratulate your state upon the re-election of Gen. Waller Taylor to the seat of the U. States. The vote stood for Gen. Taylor 21, for Judge Scott 15, and for Judge Isaac Blackford 2. Why Mr. Blackford suffered his name and influence, if he had any, to be used by the opponents of Gen. Taylor, is a question for your citizens; and when they begin to reflect upon it, tell them from me, our supreme judges are men who would scorn to have their names used for any improper purpose and are all men of great knowledge, and great independence. I hope, however, it will be found that Judge Blackford disapproved of the improper use made of his name. In congratulating you upon that event, I must tell you it is a glorious result; and when I eye some of your other public characters it presents an omen of better times. Judge Hunt, of Jefferson, remarked with truth and energy in allusion to this election, 'the American arms triumphed as they ever have and ever will when Gen. Taylor is in the field'."

"Let me also congratulate you upon the election of G. W. Johnston Esq. judge of your circuit. The vote stood for Mr. Johnston 22, for Mr. Blake, (the late judge) 9; the rest scattering. These elections of your legislature, augur I think, too favorably—it is certainly too good to be placed down amongst you, in situations where their inclination and abilities may be exercised for the general good, and if your legislature and citizens would continue thus to reward merit, I fear some of your present great men would soon be obliged to retire from public life—but mum—"

"I heard some solitary whispers about an adjournment next week, and as the bustle is all over and little good can be done, I think the sooner the better, after they dispose of business now before them."

"P. S. A certain big man of your place has been at Corydon all this time, and puffing on all occasions—without effect. What a pity!"

WHEREAS, sales of public lands were not held at the seat of Justice for Howard county, in Missouri territory, in September last agreeably to my proclamation, dated 30th of April, 1818:

Therefore, I, James Monroe, President of the United States, do hereby declare and make known, that the said lands shall be offered at public sale agreeably to law, at Franklin, in Howard county, Missouri Territory, on the second Monday in February next, viz: "thirty townships in a square form, and to include the seat of Justice of the said county, excepting from sale, the lands which may have been or may be reserved by law for other purposes—the sales shall continue for three weeks and no longer."

Given under my hand at the city of Washington, the 13th of November, 1818.
