

## SOUTH-AMERICA.

From Venezuela we may every day expect very important accounts; this province being the theatre of war, the opening of the campaign will probably furnish us with the result of some events worth recording. Bolivar and Morillo are both doubtless in the field, and, in all probability, the decisive blow has ere this, been struck, which puts the Patriots in possession of Barcelona and Cumana. We expect also to hear a confirmation of Lord Cochrane's arrival in the West-Indies, and of the arrival on the Maine of MacGregor's expedition, which left London in November last. Such a combination of force will certainly be adequate to crush the declining power of Ferdinand in Venezuela and New-Grenada, especially, as we learn Morillo has officially informed the inhabitants of Caracas, that he was destitute of the means, both in money and men, to carry on the war; and that his army was worn down to a mere skeleton.—[Wash. City Gazette.

Augusta (Geo.) December 24.

A gentleman of this city who left Pensacola the 16th inst. informs us that 500 Spanish troops, destined to garrison that place were momentarily expected from the Havana. A number of strange sail had been reported off the Bay, and were supposed to be some of the patriot privateers waiting to intercept the transports in which the above force had embarked.

Large purchases of real estate, in and about Pensacola, had been made by many of our citizens under the impression that the Floridas were ceded to the U. States. As none but subjects can legally hold a free hold under the Spanish government, great loss will no doubt be sustained by such persons as have ventured in this premature speculation.

Our information also adds, that the report of governor Massot and garrison being captured by patriot cruisers after their embarkation from Pensacola for Havana, was confirmed. They were carried to a rendezvous of the patriots, south of Campeachy, where after being detained a short time, they were conditionally released, and have since arrived at Havana.

America, written by persons entitled to the utmost confidence, which communicate the important and agreeable intelligence, that Chili is entirely evacuated by the Royalist troops. We also learn, that the Buenos-Ayres Auxiliaries were pushing for Lima.

On the 14th inst. M. De Talleyrand, (whose return to Paris we noticed a few days since,) resumed his functions, of grand chamberlain to his majesty.

A letter from Pittsburgh, received in Paris, states, that all the western banks of Pennsylvania, except Pittsburgh, Greensburgh and Brownsville, have suspended specie payments.—K. gaz.
