According to the semi-annual report of the banks of this Commonwealth made at the beginning of the present year, it appears that the aggregate amount of capital paid in, is \$2,140,600. The amount of loans and debts to the banks is \$15,914,389. The amount of bills in circulation is \$3,841,266. Amount of deposits \$3,658,853. The amount of gold and silver \$2,049,741.

PUBLIC LANDS.

On the 3d September, 1819 there remained due for lands sold by the United States, the sum of nine millions, eight hundred and sixty-eight thousand, two hundred and ninety-five dollars and forty-eight cents.

Baltimore, Feb. 8.

Extract of a letter from a respectable English merchant in Angostura, to his friend in the U. States, dated Nov. 31st.

“Despatches reached here (Angostura) up to the 15th inst. (November) from Gen. Bolivar, announcing the junction of the army under his command, with the divisions of Gen. Paez and Soublette.—The latter is on his way here, to inspect the troops of Gen. Marino, and to put the army of the east in motion, in order that the intended attack on Morillo, may take place the moment the troops can be united. Morillo at the time the last accounts left him, was fortifying him-

self in San Carlos, and Gen Morraes was in Calabaza, with a small division of Spanish and native troops.

The whole royal force is estimated at 5000 men, principally natives; and the army of Gen. Bolivar including the English and Irish troops, will be upwards of 10,000 excellent troops, and in high spirits. It is the opinion of every one here, that the present campaign will give liberty to the whole of Venezuela and New Grenada.

The greatest harmony prevails among the civil and military, and during the absence of the Vice president General Arismendi, who is gone on a visit to Maturin to see General Marino, Dr. Arbencio is charged with the administration of the Government, and has given very general satisfaction.

The government has purchased the American brig Ellen, of Philadelphia, and has fitted her for sea—she carries 16 long 18's, and 150 men, and is now cruising off the Bar for the protection of our commerce, which becomes every day more important. The number of vessels of all nations since the 1st May to the 1st inst. is 57, among which are three ships from England with troops military stores, arms and clothing, for the Legion of Gen. Devereux, 2600 of which have arrived, and the greater part of them have been landed at Caricco, and will be under the command of Gen. Marino until the General (Devereux) arrives, and who is now expected daily.

The Brigade of light artillery will leave this immediately for San Diego, for the purpose of uniting with Marino. I hope very soon to be able to give some further accounts of the operations in this quarter, and which we are all in hope will be decisive.”

Late and interesting from SOUTH AMERICA.

Extract of a letter to the editor of the Democratic Press—dated St. Thomas, 10th Jan. 1820.

“We have an arrival to day from Margarita, which brings us positive accounts that Lima is taken by the Independents under Gen. St. Martin—and that Quito had declared itself independent—and has sent Deputies to Bolivar, at St. Fee, desiring to be admitted into the Union of Venezuela and New Grenada.

“Bolivar, after establishing a government at St. Fee, and taking the Spanish General Cassaca, who, with about 400 men, had retreated into Popayan, a prisoner with his troops, has arrived with the main army, which was considerably reinforced by New Grenadians, in the plains of Venezuela.

“Bolivar himself made a hasty visit to Angostura, where he remained only 24 hours; during his stay he made General Arismendi, (who had acted vice-president,) governor general of Cumana, and Dr. Zea, was re-appointed vice-president, and is shortly to go to Rome, by way of England, for the purpose of obtaining from the Holy See Bishops, &c. &c.

“Bermudez has been appointed Governor of the Province of Socorro. Gen. Anzoategi is dead with the yellow fever.

“Mariano Montilla has arrived here from Margarita, but is to return again immediately, to take charge of the expedition now ready at that Island, the destination of which is a secret.

“Marino was, with about 5000 men at Maturin, and there fell sick, which has caused a delay of his march, and it is feared will be very detrimental to the final movements of the independents in Venezuela.

“The provinces of Venezuela and New Grenada, have taken the name of the Republic of Columbia. If possible, I shall send you a copy of the decree, dated 17th December, 1819, at Angostura.

“The next opportunity I shall write you again. I look on the Republic of Columbia as firmly established. In a few months we shall see Morillo's power at an end.

“P. S. I this moment learn that Dr. Zea is not to proceed to Europe, but to the United States, as Ambassador Extraordinary.”
