VINCENNES, MARCH 31, 1821.

Much anxiety appears to be felt by the people upon the subject of a report expected from a committee appointed by the Stockholders of the Bank of Vincennes, the State Bank of Indiana, which has been looked for and expected for some time—for the information of the people we can inform them that at a subsequent meeting of the Stockholders that committee was discharged and their duties transferred to a committee appointed by the directors, and time allowed them until the second Saturday in May next to make their report.

Gen. ANDREW JACKSON is appointed, by the President, Governor of the Territory of FLORIDA, and, it is understood, will accept the appointment.—*Nat. Int.*

Extract of a letter from Col. Alney M. Lean, a member of Congress from Kentucky, to a gentleman in this town; dated.

Yellow Banks, March 15, 1821.

Missouri is admitted into the Union upon condition that the Legislature shall declare by law, that she will never pass any law impugning the rights or privileges of the citizens of other states.

A very favourable law has passed for the purchasers of public lands. Persons who have purchased, more than one tract, may relinquish any tract they have purchased, and have the money which has been paid on it applied to the payment of the part retained. If any person will pay up the balance due on any tract, before the 30th of September, 1822, he shall have a discount of 37½ per cent.—The back interest is remitted. Tracts, on which one instalment has been paid may be paid for in eight annual instalments; tracts on which two instalments have been paid, may be paid in six annual instalments; and tracts on which three instalments have been paid, may be paid for in four annual instalments. But little business was done in Congress this session.”
