Borough Ordinances.

AN ORDINANCE respecting a site for the erection of an house for the accommodation of the poor of Knox county.

Whereas it is considered by the Board of Trustees, that a poor house erected in the immediate vicinity of Vincennes, will not only be a great convenience to the paupers in obtaining the conveniences of life and a ready sale for their surplus produce and manufactures—But add much to the improvement of the town and convenience of its inhabitants in procuring home manufactures—therefore.

Sec. 1st. Be it ordained by the Board of Trustees of the Borough of Vincennes in common council assembled and it is hereby ordained by the authority thereof,—That Genl. W. Johnston be, and he is hereby appointed and directed to propose to, and offer the commissioners appointed by an act of the Legislature of this state to select a site for the erection of a poor house in this county, ten acres of ground in any part of the Common not heretofore disposed of, in such part thereof as the said commissioners may select, and should the said offer as a donation be accepted of by the said commissioners, that then he, the said Genl. W. Johnston, immediately advertise in the two papers published in Vincennes, that he will by order and directions of this Board of Trustees, expose and sell by public outcry, at the expiration of ten days, for the most it will bring, before the court house door in Vincennes, to the highest bidder, the said ten acres of ground so selected by the said commissioners, which shall be struck off by him to, and in the name of the directors of the poor house for the county of Knox, and their successors in office; any thing in the ordinance directing the manner of surveying the Common and prescribing the terms of sale—passed the 28th September, 1818, to the contrary hereof in any wise notwithstanding.

Sec. 2. Be it further ordained. That in case the said commissioners, should accept of the present donation, and the agent herein appointed make sale thereof as before directed, it shall be and is hereby made his further duty to inform the chairman of this board thereof who shall immediately call and convene the board for the purpose of making and executing a deed to the said Directors and their successors in office, for the said ten acres of ground, in fee simple.

Sec. 3. And be it further ordained, that the said agent for his services, as herein contemplated, shall be allowed have and receive the sum of ten dollars, which together with the cost of the land, & the expense for advertising, shall be paid him, and the respective printers, by the Treasurer of the Borough out of any monies in his hands, or which may hereafter come to his hands, upon the order of the chairman attested by the Secretary of the Board.

This ordinance shall take effect and be in force from and after its passage.
