

the whole truth, & they acted up to their avowal as closely as men could act, under their circumstances. It was not they who bound with fetters, stronger than iron, the minds and the bodies of the unfortunate Africans—our brethren, the children of the same great Parent! These fetters it was not theirs to break—much they did; all they could not do. They pledged their lives, their fortunes, and their sacred honor, to support these principles, and they redeemed their pledge. To us, their successors, belongs the furtherance of the great work they commenced so nobly—Let us, my friends & fellow citizens, follow their example; and, relying as they did, on the protection of Divine Providence, do our utmost to promote the restoration of every individual of God's creation to the enjoyment of his inalienable rights, of life, of liberty, and the pursuit of happiness.

Deferred Articles.

LEIPSIK, June 3.—The accounts from the North are not pacific, and it is still believed there will be war, because it appears to be inevitable. The exchange of couriers between St. Petersburg and Paris is very frequent, from which it is with reason concluded, that important negotiations are carrying on between the governments of those two countries.

VIENNA, June 2. We are well satisfied here with the accounts received from St. Petersburg. The Emperor of Russia has agreed to all the propositions made by our cabinet; and the affairs with Turkey may be regarded as arranged. M. de Tatischeff will come here in ten days, and will be charged to make verbal communications. The period will then be fixed for an interview between the Sovereigns. It will probably take place about the end of September, in a town of Italy, subject to Austria.

Intelligence from Russia confirms, in a great measure, the prospect of peace.—The Turks are, no doubt, evacuating Moldavia and Wallachia, but declare that they will have a brush with the Russians before they turn out.

The Emperor Alexander seems dejected and fallen from his high estate, from which he never will, nor never can, nor never should, recover; and the evil results of his timid, peevish policy, will be deeply felt in the disaffection of his army, which, it will be perceived, has already been manifested by rebellion and disorder. He pretends to weep over the sufferings of the Christians in the East.

In Spain there is great disorder and confusion. Provinces in rebellion, and trouble in the camp; added to which, heavy battalions of French troops are marching towards Spain. The London Courier says "The Paris papers of Tuesday have reached us. The intelligence they contain of the movements of troops towards the south of France, might justify the expectation of some warlike projects with regard to Spain; or, at least, the apprehension of danger in that quarter, by the French government. And danger there unquestionably is; but what form and character it may assume, or whether events avert it, are points which it would be unprofitable to discuss at the present moment."
