**Ancient Relick.**—There has been found in the river, near this place, (Indianapolis,) since its settlement by the whites, a stone, weighing about 10 or 12 pounds, with two smooth sides to it, on one of which there are several engravings apparently of very ancient date. Some of them cannot be deciphered. The number 1110 is as plain as if it had been engraved but a short time since. Another word, a part of which is very plain, is taken to be JULUS. Several of the letters are spread as if the stone had grown since they were engraved. The letters are cut in Roman capitals. There remains a visible appearance of other engravings, which cannot be made out. The stone is now in the possession of a gentleman of this town. An inspection of it would no doubt afford pleasure to the curious antiquarian. Western Censor.
