ARMY OF THE PYRENEES.
From the Paris Moniteur of September 5.

OFFICIAL.

Report of the Major General of the Army of the Pyrenees, of the military operations since the arrival of his Royal Highness before Cadiz.

On arriving at Porto Real, the 16th of August, his royal highness ordered lieut. general Viscount Dade, commanding the Engineers, to reconnoitre the line from the Trocadero to St. Petrie. His royal highness immediately advanced the third regiment of the guard from Santa Maria to Puerto Real, to be employed together with the thirty sixth of the line, in the regular attack of the Trocadero.

Attack of the Trocadero.—On the 20th, 21st, 22d, 23d, 24th, and 25th, we debouched from the Angouleme battery, which mounts six 24 pounders, and the works were pushed to the second parallel, which is formed to-day 15 toises from the section (*coupie*). A battery of six howitzers has been erected to the right of the first parallel, to batter the interior of the Trocadero, and to enfilade the course of the Rio San Pedro against the gun-boats. Another battery has been placed at the centre and the second parallel. A battery of mortars is placed in the centre, and behind the two former—

Lastly. A fifth battery of four howitzers, on the right bank of the San Pedro, takes the back of Trocadero, so that is battered by six 24 pounders, fourteen 6 inch howitzers, and two 9½ inch mortars.

St. Maria, Aug. 31—3-4 past 2 o'clock.
The Trocadero was carried with great vigor. The enemy had 150 killed, 250 wounded, and 900 made prisoners.

The Duke of Angouleme has issued a decree declaring the Cortes to be outlawed.

Attack of St. Petre.—On this side a battery of four 24 pounders is raised opposite the redoubts, which defend the entrance of the canal of the Santa Petre; but there as before the Trocadero, the works are impeded by the difficulty caused by the sand, which is every where met with. We shall be obliged to employ bags of earth and gabions.

Preparations for embarking.—The six battalions of the second corps, as soon as they arrived at Xeres, on the 19th, were advanced the same day to Rota. On the 20th, 21st, and 22d, the five battalions of the guards arrived from Madrid, have been successively placed, there on the same point, and two at Santa Maria.

Sixty barges, each capable of containing fifty men, are collected at Rota, as many more are expected: they are to be organized in divisions of 10, with their commanders and pilots. The troops are exercised in embarking and disembarking. They are also exercised in sailing, to accustom them to the sea. Five hundred men of the brigade of Ordonu have been embarked on board the fleet.

Flotilla.—The number of gun-boats placed at the disposal of the Admiral is at this moment 36, including those of small calibre employed in the blockade.—In a few days there may be 30 gunboats and 9 bombs.

Marine.—Rear Admiral Hamelin has received from France the Le Cybèle and Le Bretone brig. Two Portuguese corvettes and a mastick, have joined the squadron, but can only be employed for the service of the blockade, according to the intentions of the Portuguese government.

Several reconnoisances have been directed to the west coast of the isle of Leon, to be sure of landing places.

SPAIN—IMPORTRANT

The editors of the New York Daily Advertiser, have made a translation of the following important decree of the cortes of Spain, which they say has not been published in this country before.—

It appears that the body passed a solemn act on the 2d of August last, *not to receive or listen to any proposal from any foreign government whatever, intended to effect a modification in the Spanish constitution.* It follows, of course, that the mediation of England, even if offered by her self, cannot be accepted: for on the 5th of August, the cortes adjourned and the executive of Spain not authorized to negotiate with any foreign power."

Among the various stratagems resorted to by the enemies of Spain to depose and annoy, to destroy confidence and introduce anarchy and division of

opinion, none have produced evils of such magnitude, as the impression that the cortes were negotiating with the French government. The memorable session of the 9th and 11th of Jan. last, and the discussion for removing the government from Madrid to Seville, should have presented a public and incontestable proof of the firmness and determination of the cortes to adhere to their oaths. Nevertheless, the cortes being convinced that the enemy will not desist from his machiavellian projects, which has been urged of late, with great pertinacity, and it being probable the same will be pressed with increased energy as soon as the legislature adjourns, they hereby declare in the most solemn manner to the nation, that the present members have not listened, nor will they listen, to any proposal, from any foreign government whatever, having for its object a modification or alteration of the political constitution of the Spanish monarchy sanctioned at Cadiz in 1812; for they cannot fail in the sacred duties expressed in the powers conferred on them.

The cortes have resolved, that the government give the greatest publicity possible to this declaration, by circulating it in the usual manner, and likewise by ordering it to be read in all the corps of the army.
