

discharge of their respective duties, make oath and declare, that they do not, nor ever have belonged to any lodge, secret society, either of freemasons or others, whatsoever; and that they deny the absurd principle that the people have the right of changing or altering the established forms of government.

11. The same formality shall be observed in regard to all universities, students, &c.

The 12th, 13th, 14th and 15th articles relate to privileged persons, such as ecclesiastics, &c. none of whom are exempted from being obliged to declare what they may know, or suspect, of secret societies, and their members.

The "Noticioso Mercantil," of the 5th instant, contains a decree, dated the preceding day, of general Francisco D. Vives, captain general of Cuba, establishing a military commission, whose duty it is to arrest and try all persons suspected of being unfriendly to the king of this government, or to be partisans of the constitution; or any person or persons belonging thereto, or who may be accused of seducing others to enter into any prohibited association or society. This decree is grounded on the royal decree of the 13th Jan. 1824 issued by Ferdinand, "the more effectually to preserve his dominions in America from the horror and ruin with which they are menaced by the unloyal spirit of reform."

The immediate cause of the proposition to increase the army of Great Britain, appears to have excited, in an unusual degree, the curiosity of the London prints, some of which indulge in a very free discussion of the subject. The King's speech assigned, as we understood it, two reasons for the measure—one was, the continuance of the wars carried on by the native governments of the East Indies against the British establishments there; the other, the unsettled state of affairs in Ireland. The London Morning Chronicle, an extract from which will be found in another column, attributes it rather to the possibility of an expected rupture with the Continental Powers of Europe, in consequence of the recognition by England of the Independence of South America.

We are indebted to the keeper of the Merchants Coffee House, Mr. Sanderson, for a Paris paper of the 31st January, which was kindly transmitted to him from the office of the New York Commercial Advertiser. It furnishes nothing of particular interest, except the following extract of an article, dated Madrid, Jan. 20.

"The note in which the English diplomatic agent announces to our government that England has recognised the independence of the three states of America was communicated the day before yesterday, to the extraordinary council of ministers, to the charge d'affaires of France, and to the ministers of the northern powers. This note has raised alarm in all minds. The most bigoted now consider the loss of America as certain, and a rupture between some of the powers of the Holy Alliance as more than probable." Phil. Nat. SPAIN.—The following is our latest information from Spain, and is not destitute of interest:

MADRID JAN. 27.—Our Government, after great labor, have perfected a plan of Representative Government, suited to the state of knowledge in the Peninsula, and to the extensive Aristocratical elements which exists there. I can tell you nothing of my own knowledge of the contents of this project, but once more I assure you of its existence; and I can equally assure you copies of it have been given to the French, Russian, Austrian, and Prussian Ministers, that they may transmit them to their respective Courts, to be examined. I can add to what I have just told, that persons who are intimate with our Ministers, and who are in the habit of reading their thoughts, pretend that the new plan is nothing more than the renewal of a project of the Ancien Council which was agitated six months ago, with, however, a few insignificant modifications.

STATE SEMINARY OF INDIANA.

NOTICE.

THE Trustees of this institution are authorized to inform the public that the Seminary buildings are now in a state of preparation, and will be ready for the reception of Students by the first Monday of April next; at which time the first session will commence under the superintendence of the Rev'd. BAYNARD R. HALL, whom the trustees have engaged as a teacher. Mr. Hall is a gentleman, whose classical attainments are perhaps not inferior to any in the western country; and whose acquaintance with the most approved methods of instruction in some of the best universities in the U. States, and whose morals, manners, and address, render him every way qualified to give dignity and character to the institution.

There will be two sessions of five months, in the year.

The admission fee for each scholar at the commencement of every session will be two dollars and fifty cents, making the expense of tuition for a year the sum of five dollars.

The institution will for the present be strictly classical, and each scholar will be required to furnish himself with a supply of classical books, of which the following are recommended, and will be needed from term to term.

Ross's Latin Grammar, latest edition.
Colloquies of Corderius, Latin.
Selectae e Veteris, do.
Selectae e Profanis, do.
Caesar, do do.
Virgil, and Mairs' introduction, do.
Valpy's Grammar—latest edition. Greek.
Testament, do.
Græca minora, do do.

None of these books are to be accompanied with an English translation, but this remark is not intended to extend to such editions as have notes in English; which indeed for beginners are preferable.

The choice of Lexicons in either language is left discretionary with the student: Ainsworth's in Latin and Schrevelius' in Greek, are however recommended. Other books than these specified, as progress in the languages is made,

will hereafter be necessary; but these only at present need be procured. The whole number of students according to the different degrees of improvement, will be distributed into several classes in which the books just enumerated are to be employed.

The Seminary buildings are erected on an elevated situation, affording a handsome view of Bloomington the county seat of Monroe county, and also a commanding prospect of the adjacent country which is altogether pleasant and well calculated for rural retreats; and as it regards the healthiness of its situation, we hazard nothing in the assertion, that it cannot be excelled by any in the western country.
