

energetic conduct of the new Russian ambassador relative to the pacification of Greece, no important change has occurred in affairs. Mr. Stratford Canning has as yet received no answer from the Divan, to his note of 5th February; and as the language of the Reis Effendi, to that Minister, as well as to Mr. Ribeauville leave little hope that the Porte will acquiesce in their demands, it is understood that the two ambassadors have agreed to wait until a certain day, in order to take together some more decisive steps.—Count Guilleminot, the French ambassador, though it does not appear that his Court has formally acceded to the views of Russia & England respecting Greece, has nevertheless advised the Reis Effendi to acquiesce in them.

March 11.—The indirect accession of Austria and Prussia to the course pursued by the English and Russian ambassadors, was limited, as is believed, to advising, merely, the Reis Effendi to accept the proposition of those two powers. It is inferred, however, from this, that the Courts of Berlin and Venice will accede to the protocol of the conference of the fourth April. All this, taken together, is only calculated to persuade the Porte, the more firmly, that the European powers will content themselves with mere demonstrations. Meantime, armaments are going on at the arsenals, and the new military organization is proceeding rapidly. At Athens, affairs seem to have taken a favorable turn for the Greeks.
