The superannuated Mr King was sent minister to London: the Hartford conventionist, Mr. Webster, was made manager of the H. of Representatives, and the tory editor of the Boston Sentinel, Mr Benjamin Russell, who had hoped that the British troops which burnt Washington City, would not confine themselves to defensive operations, and that they might gather new laurels of Americangrowth, was selected as public printer to the federal government!—*ib*
